- v) That I have not visited any foreign country earlier.

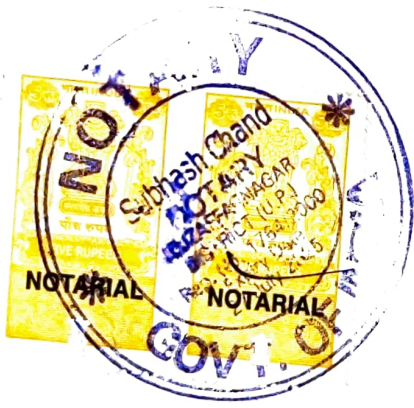
