
It is, therefore, requested that the L.L.M. Degree may kindly be placed before the Hon'ble Court for inclusion in service records of the undersigned.



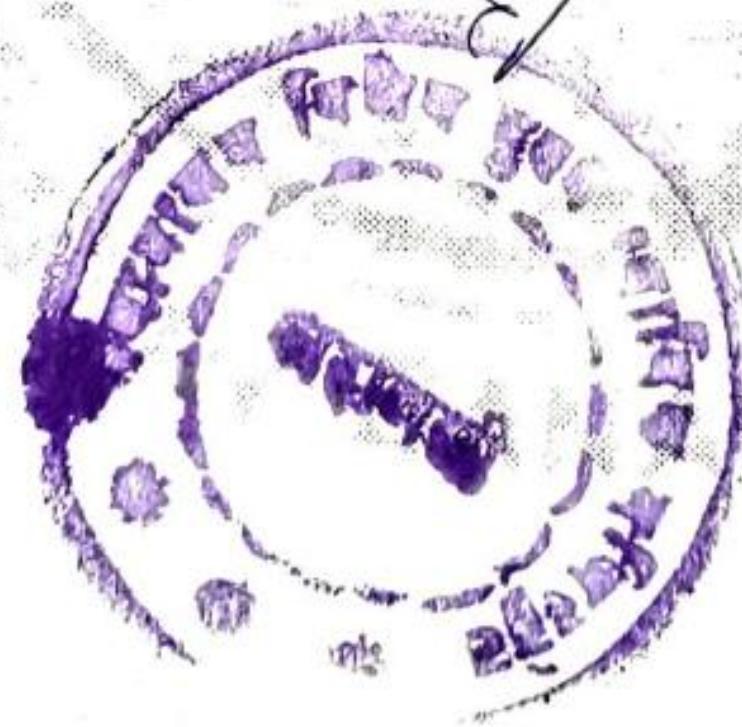
