As per the self assessment form the Officer was posted as District & Sessions Judge, Sitapur from 20.7.2019 to 04.1.2020. As per the self assessment the Officer has achieved 1369.60 units against the required target of 586.62 units during the period under assessment which is quite adequate. The judgments delivered by the Officer appear to be well-reasoned, sound and expressed in good language, appreciating proper evidence and principles of law. The Officer has decided sufficient number of civil and criminal cases on merits during the period under assessment. The Officer has taken steps to dispose of old matters and also decided sufficient number of old cases during the period under assessment.
