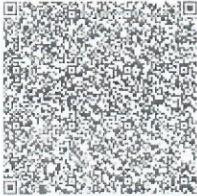

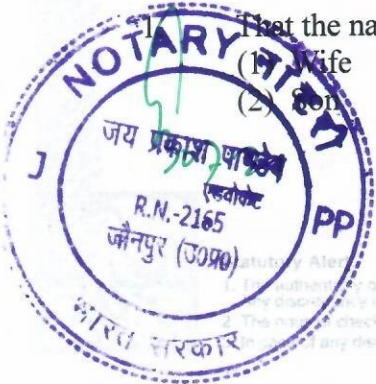

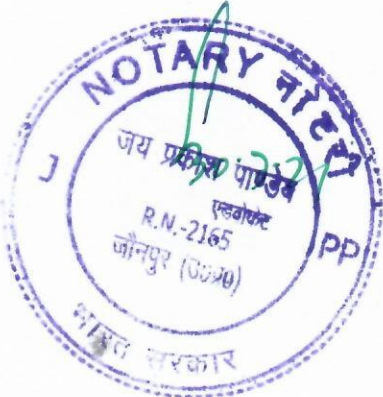
2. That I am a continuous resident at the above mentioned address from Birth.
