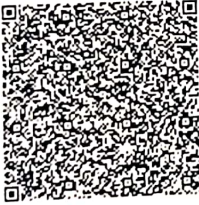
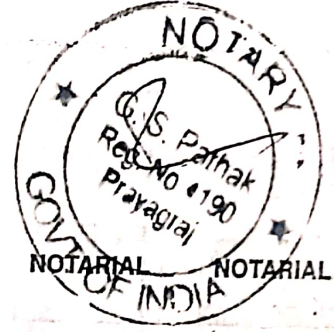

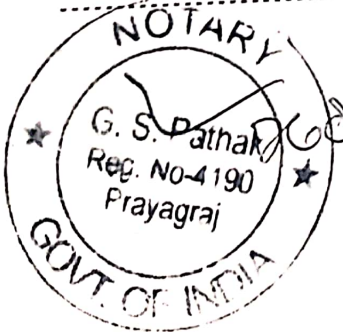

AFFIDAVIT

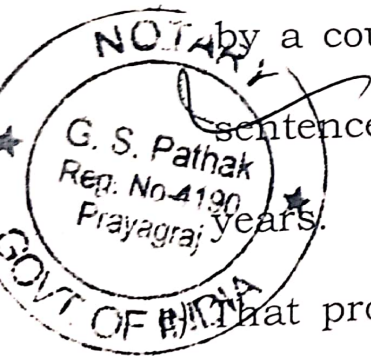

years. That proceeding in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India.

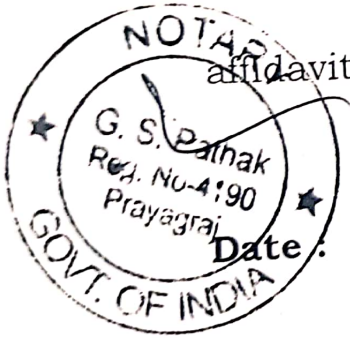
- f) That a warrant or summons for the appearance or a warrant for the arrest of the applicant has not been issued by a court under any law
