It is humbly submitted that my brother-in-law Sri Sandeep Jaiswal has been living in Dubai (UAE) since long. He is the Director of a Dubai Based Company named Global Alliance Group DMCC. He has invited me to visit Dubai and also planned for a family trip to Maldives.

So, I have been planning to visit Dubai & Maldives at any time between third week of December, 2021 to January, 2022. Since the exact dates for the visit have not been finalized yet, the same will be intimated to the Hon'ble Court later on. The duration of the whole trip will be about 20 days. The expenses of to & fro Air Ticket, Lodging & fooding etc. of visit, approximately Rs. two lac, will be borne by my brother-in-law. I have also got sufficient amount in my saving bank account to bear expenses of the trip. The sponsorship letter of my Brother-in-Law, statement of my saving bank account (SB A/C No. 10880411275) and photocopies of passport of my family members are being enclosed with this application. Passport of my younger daughter was expired in July, 2021 but I have applied for reissuance of the same, which is likely to be issued soon.

According to the Rule/Guideline of Hon'ble High Court (C.L. No. 16/IV f -101/Admin A/dated 21-05-2017) Abroad Tour shall not be availed by any officer during working days of the courts and be permitted to go abroad only during vacations / official holidays.
