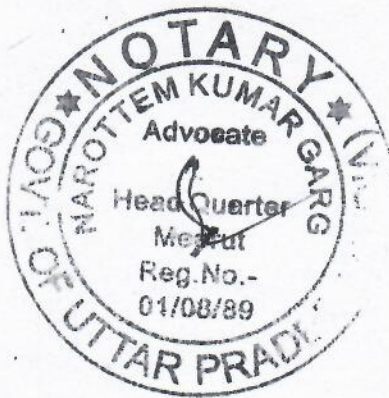

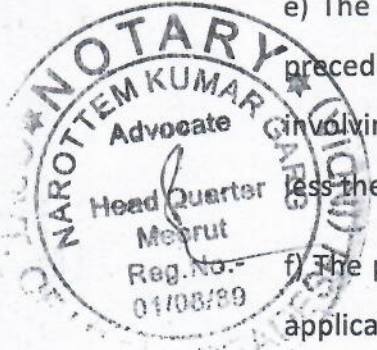
Affidavit of CHHAYA NAIN aged 44 years Approx , Additional Principal Judge, Family Court Meerut is as follows:-
