- (a) That the Lessee will bear, pay and discharge all rates, taxes, charges and assessments, of e description which may during the said term be assessed, charged or imposed upon either the landlor tenant or the occupier in respect of the demised premises or the building to be erected thereupon.
- (b) That the Lessee will obey and submit to the rules of municipal or other authority now existin hereafter to exist so far as the same relate to the immovable property in the area or so far as they affect health, safety convenience of the other inhabitants of the place. 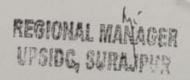

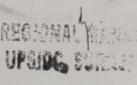

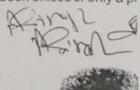
