Sub: Information regarding the purchase of a plot no. A-36 measuring 167.225 sq.meter in the Spring Garden Society, Lucknow (LDA Approved and RERA registered Society) jointly owned in the name of my wife Smt. Umang Srivastava and myself Ajay Kumar Srivastava.

Hon'ble Sir,

With reference to the aforementioned subject, it is to be humbly informed that I have purchased a plot no. A-36 measuring 167.225 sq. meter vide registered Sale Deed dated **06.03.2020** in the Spring Garden Society, Lucknow through authorised dealer. The said society is LDA approved and RERA registered. Lucknow Development Authority has approved the map of the said purchased plot for construction and issued a certificate in my favour. Total Sale consideration for the purchase of the said plot was **Rs. 63,00,000/-(Sixty Three lacs)** excluding Rs. 4,41,000/-(Four lacs Fourty one thousand) for the purchase of e-stamp charges. In addition to that I had also paid Rs.45,000/- as Interest Free maintencance security charges and Rs. 25,488/- for AMC charges through cash. Initially, at the time of purchase of the said plot, I took the home loan from SBI IIT branch Kanpur Nagar to the tune of Rs.66,00,000/-(Sixty six lacs consisted of Rs.50 lacs for the purchase of land plus 16 lacs for construction purposes) and for remaining sale consideration, I took personal loan to the tune of Rs. 15 lacs from SBI IIT Kanpur and accordingly the total sale consideration was paid by me for the purchase of land and rest of the amount has been utilized for the construction.
