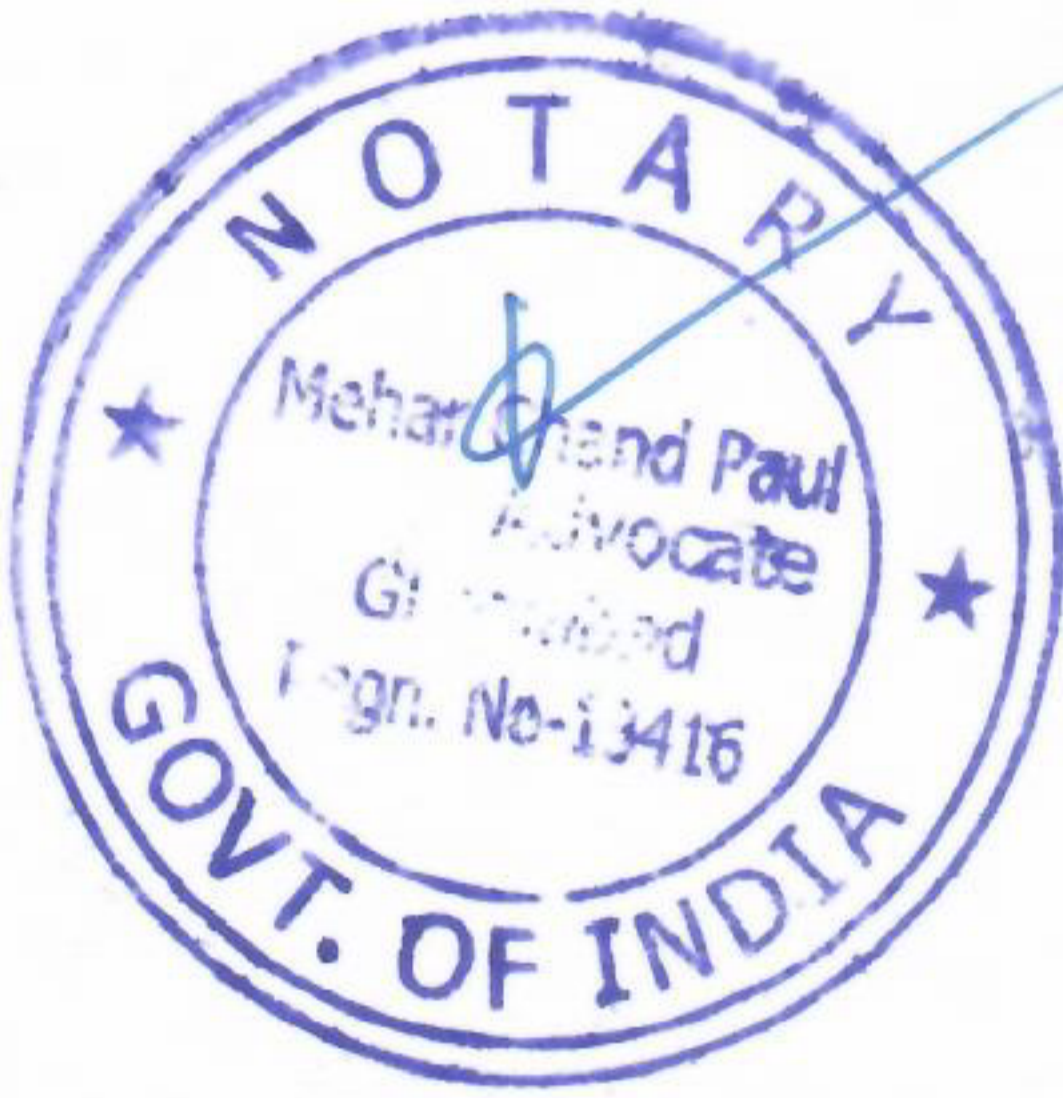

(b) that the applicant is a citizen of India.

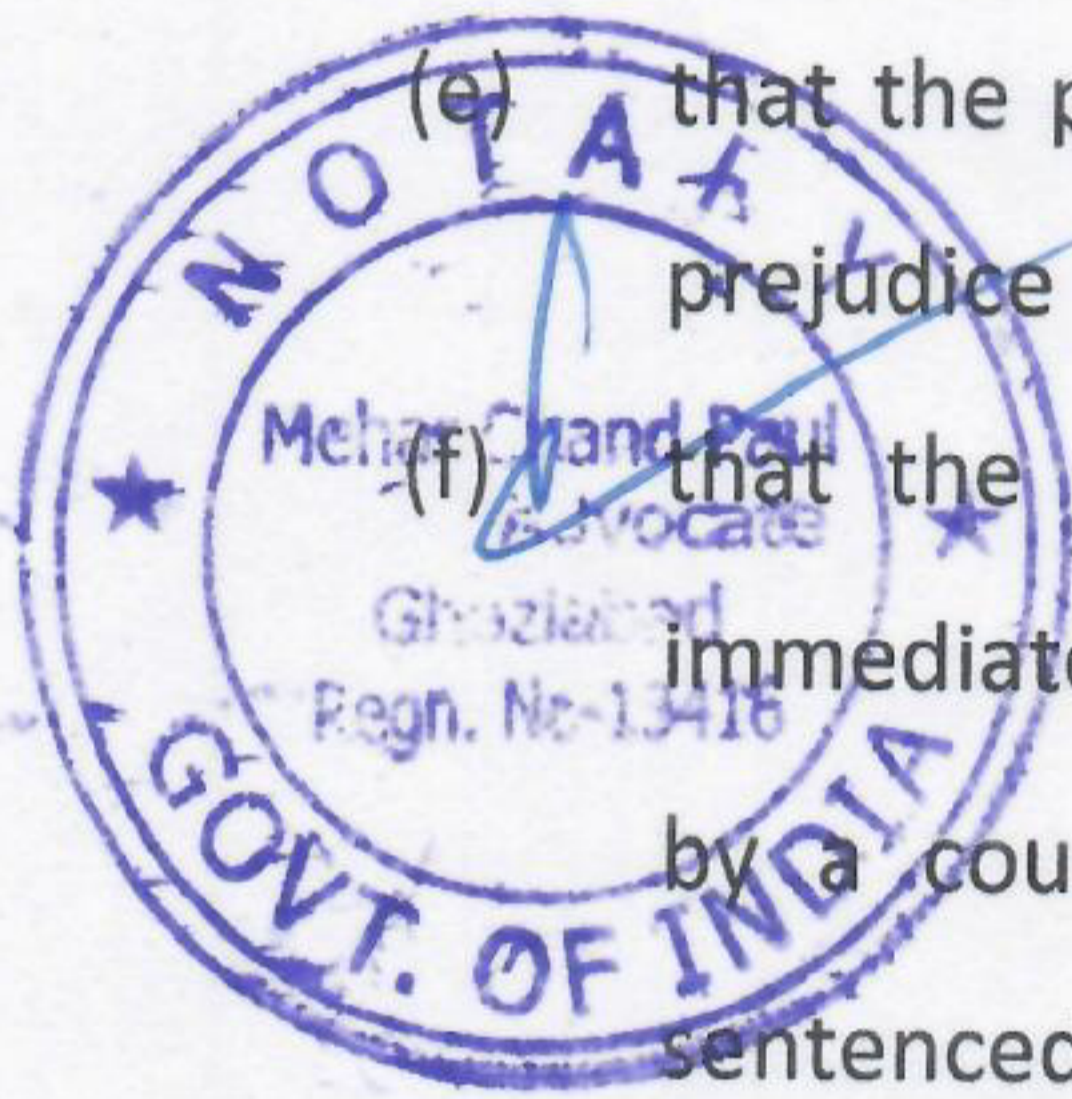
(c) that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India.
