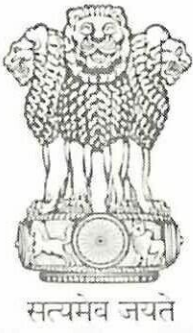

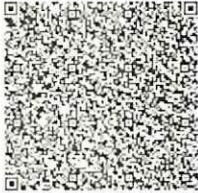

- 13- That I had visited Kingdom of Saudi Arabia for performing Haj with my wife in the year of 2012 with the prior permission of the Hon'ble High Court.

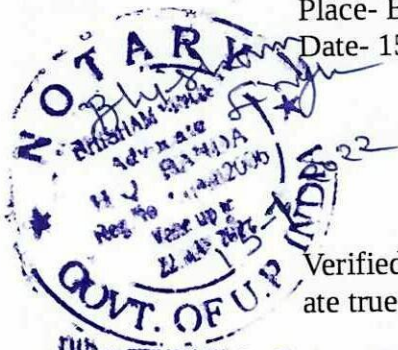
