
sentenced in respect thereof to imprisonment for not less than two years.

- (h) that the applicant has not been repatriated.
- (i) that there is not any possibility of arising of any embarrassing position before the Government of India or Uttar Pradesh due to his visit to any foreign country.
- (j) that the issue of Identity Certificate for obtaining a passport has never been refused to him.

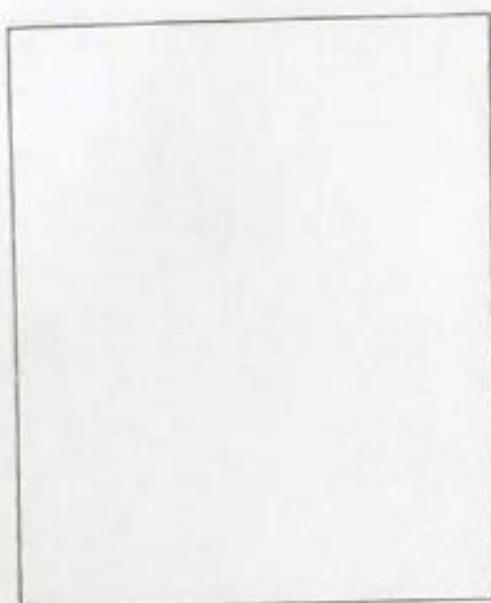
