Subject:	Application for the permission to accept the gift of Revolver from my Father.
Dear Sir,	Respectfully, it is submitted that my father, a retired officer, Sri Devendra Kumar Garg s/o Late Sri K.S.Garg, age 65 years, permanent r/o L-41, Shastri Nagar, Meerut, is presently residing with me at J-5, Judges' Colony, Civil Court Compound, Amroha.
	That my father had purchased a N.P. 0.32 Bore revolver No. A-2759 made by Indian Ordnance Factory (Small Arms Factory), Kanpur on 30.12.1997 for Rs. 60387/- Copy of Receipt is Annexed) and this revolver is endorsed to his License No.1523GS Kotwal Budaun (Copy Annexed). Thus he is the owner of above mentioned revolver and has all rights to self transfer of his revolver. It is further submitted that I am also a license holder of a N.P. 0.32 Bore revolver bearing License No. 313P-J GS Amroha , Amroha (Copy Annexed) and I need a revolver for my personal defence.
	Now, since my father has 3 weapons in his name, therefore, he has decided to give above mentioned revolver to me by way of gift, out of love and affection and without consideration as I am his only daughter and in order to proceed with transfer of his revolver to me my father has made a gift in favor of me which is final as well as irrevocable (Copy Annexed) in which he has declared that he would have no objection if I would apply to seek permission from Honble High Court, Allahabad prior accepting this gift and later apply to concerned District Magistrate for endorsement of my name in my license, as owner of revolver No. A-2758.
	Now, since it is necessary for me to obtain prior permission from the Honble High Court before accepting this gift, therefore, it is requested that please place my application before the Honble Court for granting me the prior permission to accept the gift of revolver from my father.
