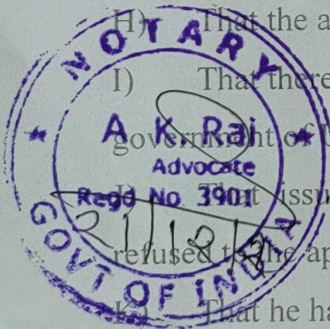

I, **Ashwini Kumar Upadhyay** s/o **Shri Surendra Upadhyay** age about 30 years presently posted as **Additional Civil Judge (J.D.) Court No.-3, Varanasi** resident of **J2/8 Parikh Compound near Central Jail Road, Varanasi U.P.**, do hereby solemnly state on oath as under:

- A) That the applicant is a citizen of India.
- B) That the applicant may not, or is not likely to engage outside India in activities prejudicial to the sovereignty and integrity of India.
- C) That the departure of the applicant from India may not or is not likely to, prejudice the friendly relations of India with any foreign country.
- D) That the presence of the applicant outside India may not, or is not likely to, be detrimental to the security of India.
- E) That the applicant has at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- F) That proceeding in respect of any offences alleged to have not been committed by the applicant are pending before a criminal court in India.
- G) That a warrant or summons for the appearance, or a warrant for the arrest of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- H) That the applicant has not been repatriated.
- I) That there is no possibility of arising embarrassing position before the Government of U.P. due to his visit to any foreign country.
- J) Issue of "Identity Certificate" for obtaining a passport was never refused to the applicant.
- K) That he has not visited any foreign country earlier.
