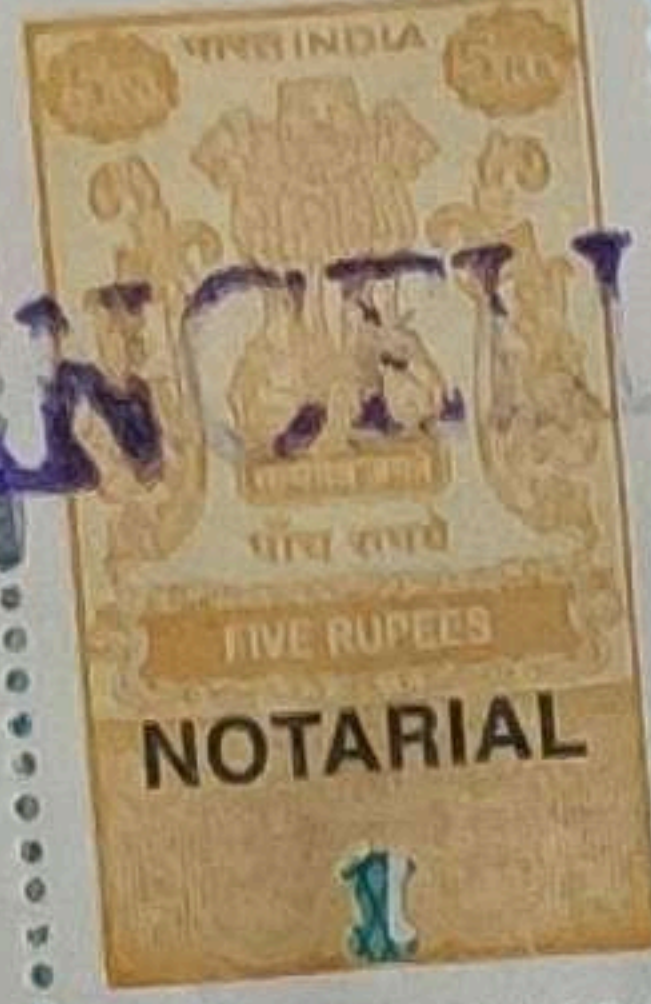
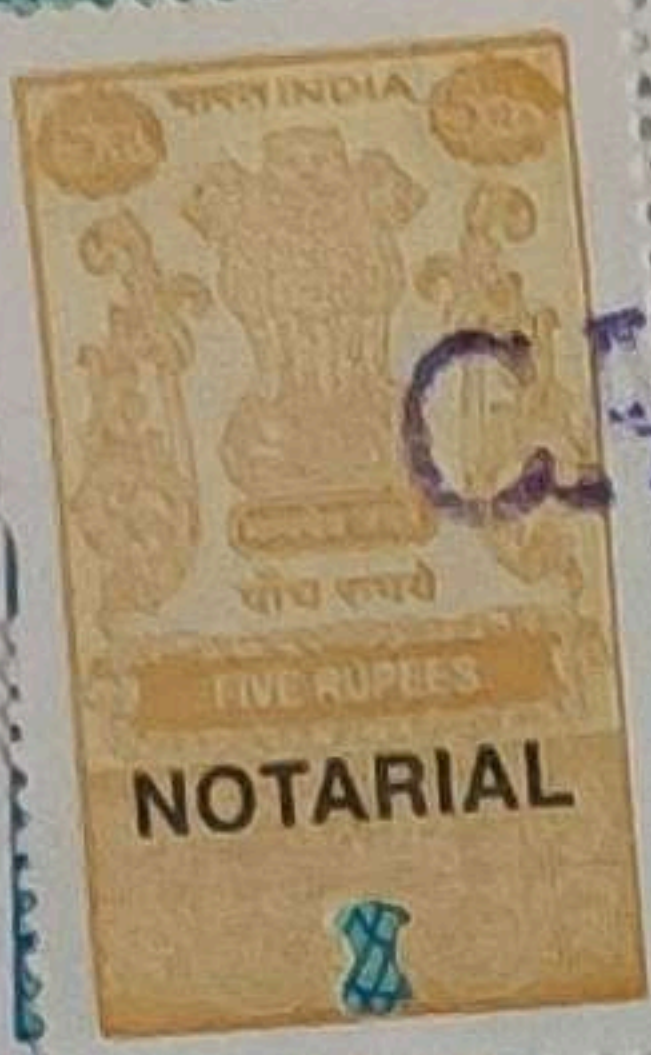

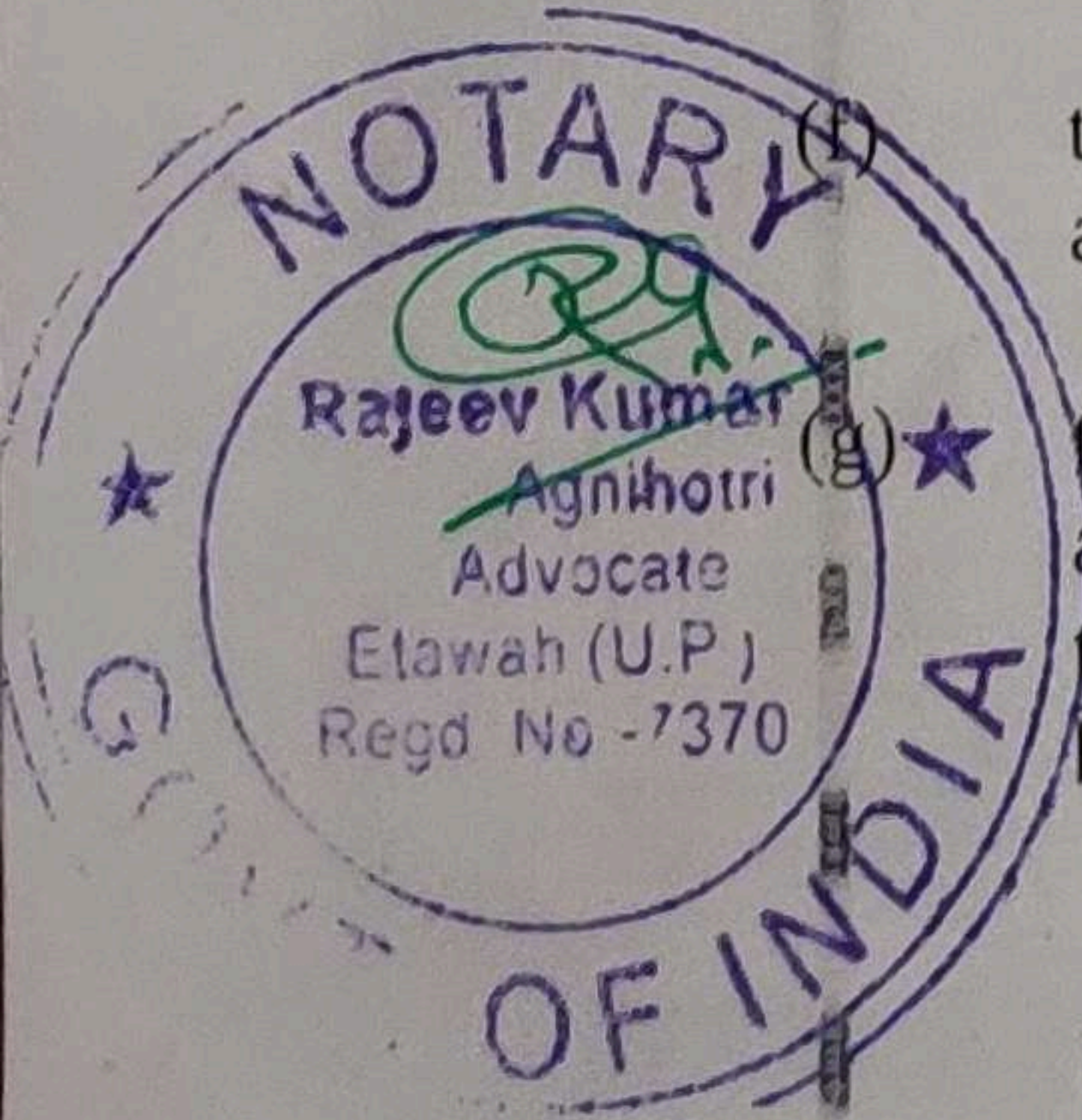
AFFIDAVIT

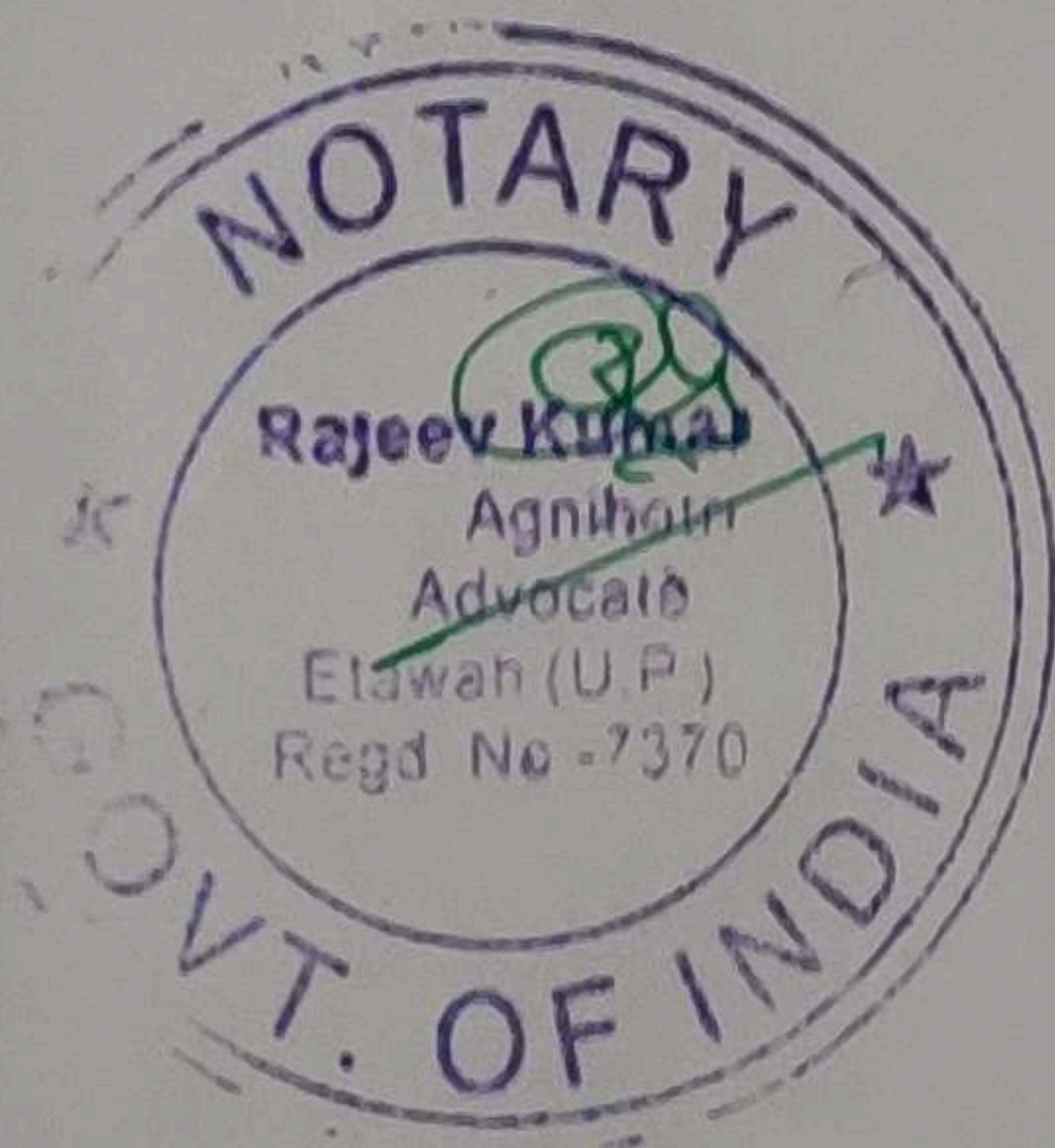

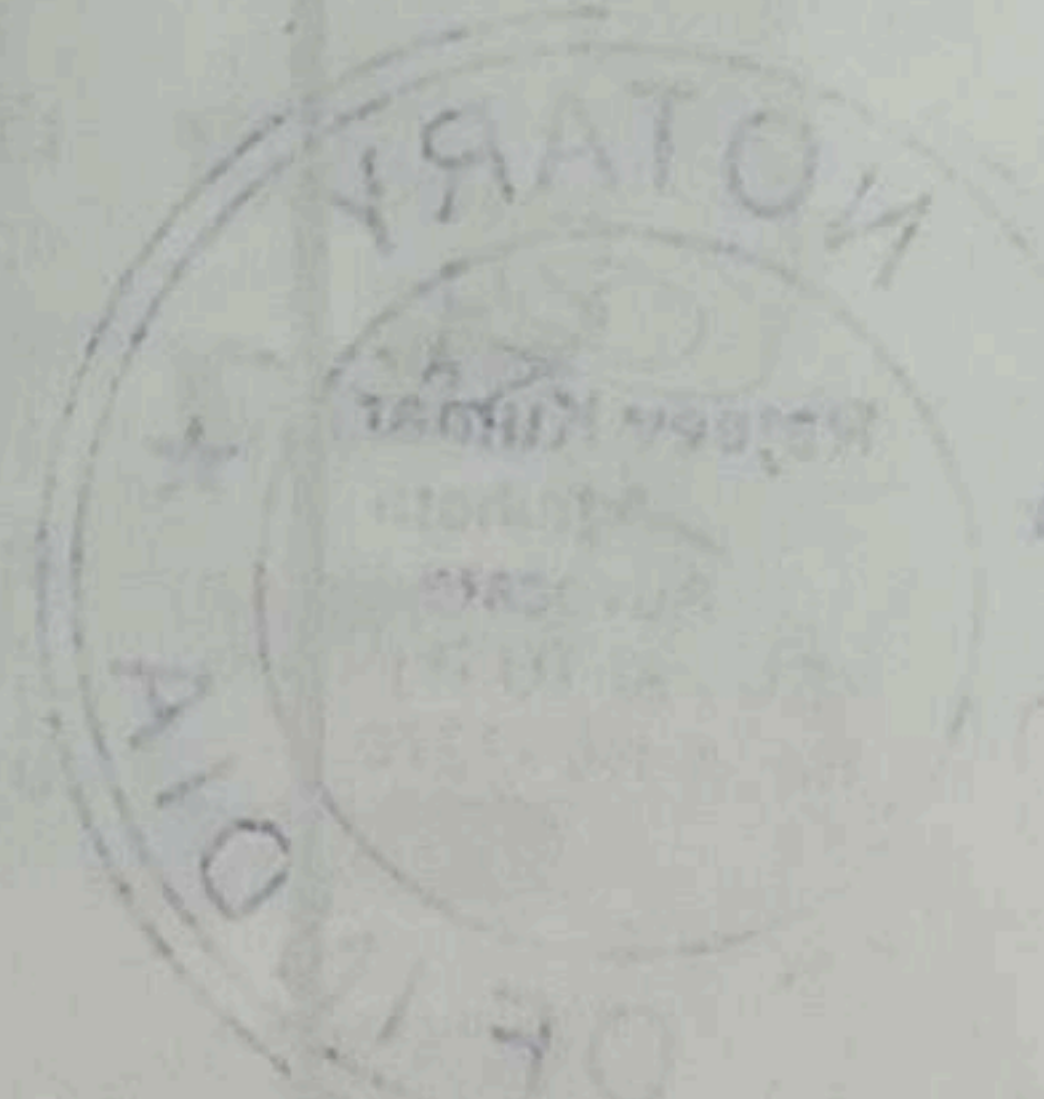
