With due reverence, it is humbly submitted that I had prayed to the Hon'ble Court through eServicesJO mode vide application id 823 dated 24.07.2020 for inclusion of LL.M degree in my service records. In this regard, it is further submitted that as per the G.O. No. 8/2018/279/II-4-2018- 45(12)/91 T.C dated 13.04.2018 & G.O. No. 15/2018/940/II-4-2018-45(12)/91 T.C dated 18.09.2018, provision exists for grant of three advance increments to judicial officers having LL.M qualification.

It is relevant to mention here that I joined Uttar Pradesh Nyayik Sewa on 28.09.2018 and completed LL.M programme on 21.08.2018 and was subsequently awarded LL.M degree from Babasaheb Bhimrao Ambedkar University, Lucknow on 11.11.2019.

Thus, it is requested that benefit of three advance increments may kindly be granted to me as per existing rules.
