
Respected Sir,

Sir,

With reference to your endorsement no. 3/20/I dated 05.12.2022, I am desired to say that information furnished by Sri Prikshit, Nyayadhikari, Gram Nyayalaya, Siyana-Bulandshahar vide his letter dated 02.12.2022 about his successful selection as Civil Judge(Junior Division) in Haryana Judicial Services has been placed on record of this Court.

However, with respect to his submission about his willingness to join same, I am to say that in order to be able to join other service, the concerned officer needs to seek proper relieving from Hon'ble High Court while tendering his unconditional and voluntary resignation from U.P.Nyayik Sewa, in accordance with The U.P. Temporary Government Servants (Termination of Service) Rules, 1975 or The U.P. Government Servants' Resignation Rules, 2000, as the case may require.
