Sir, the above car was 2011 made and several technical and mechanical faults had crept into the car. It was due to that reason I had sold that car to *Mr. Ramagya Yadav s/o Late Chauthi Yadav r/o Khanpur Bujurg, Post Ghosi, P.S. and Tehsil Ghosi, District Mau, Uttar Pradesh* on 12-12-2022 for Rs. 1,30,000 (Rupees One Lakh Thirty Thousand). However after certain deductions and discounts, final ex showroom price was Rs. 4,79,642. The on-road price of the car is Rs. 6,00,001 (it includes insurance, registration, extended warranty, Accessories and MSR).

For purchasing the car, on 12-12-2022, Rs. 5,001 was transferred by me through UPI No. 234606645025, as the booking amount. The UPI is linked with my salary account no. 31830901624 maintained with State Bank of India, Ghosi City Branch. Further on 13-12-2022 Rs 65,000 was transferred by me through the UPI having UTR No. 234715507405. Further, I have paid Rs. 1,30,000 in cash. This cash amount has been received by me as the consideration amount for selling my old car i.e, Wagon R LXI Duo bearing registration no. UP-50-Y-9860.
