



Details of Existing Damages --

Follow these rules like you follow the rules of the road.

Cover for Owner Driver under Section II (CS) - ₹1500000.

NCB Declaration: The premium has been charged and policy has been issued subject to NCB declared by you as an insured. In the event of NCB found wrongly declared at any point of time during policy period, all benefits and coverages under the Policy in respect of section I of the Policy will stand forfeited.
