माननीय महोदयजी विदित हों कि दिनोंक 01-04-2005 के उपरान्त केन्द्र सरकार व राज्य सरकार के अधीन सेवा में आने वाले अधिकारियों/कर्मचारियों को पुरानी पेंशन योजना का लाभ अनुमन्य नहीं किया गया है, परन्तु केन्द्र सरकार व राज्य सरकार के अधीन सेवा में दिनोंक 01-04-2005 से पूर्व जो भी अधिकारी/कर्मचारी कार्यरत रहे हैं और सेवाकाल के दौरान उत्तर प्रदेश, सरकार के अधीन अन्य विभाग में चयनित होकर नियुक्त हुए हैं, को पुरानी पेंशन योजना का लाभ अनुमन्य किया गया है। उक्त के सम्बन्ध में माननीय उत्तर प्रदेश, शासन द्वारा अधिसूचना संख्या-सा-3-1118/दस-2011-301 (09)/2003 टी0सी0, दिनोंकित-16-09-2011 निर्गत किया गया है, जिसके पैरा संख्या-03(1) में यह निदेश हुआ है कि :-

1st Financial up gradation granted to the above officials under MACP Scheme is subject to the following terms and conditions laid down in D.G.Posts, New Delhi letter referred above:

1. It should be ensured that the officials must have completed 10 years regular service in the department on the date allowing the higher scale.
2. The MACP schemes envisages merely placement in higher pay scale through financial up gradation to above officials on personal basis and shall therefore, neither amount to functional /regular promotion nor would require creation of new posts for the purpose. On grant of financial up gradation under the scheme, there shall be no change in the designation, classification or status.
3. Three financial up gradation under the MACP scheme in the entire Govt. service career of the employees shall be counted against regular promotions (including in-situ-promotion and fast track promotion availed through limited Departmental Competitive examination) availed from the grade in which an employee was appointed as a direct recruit.
4. The financial up gradation under the MACP scheme is purely personal to the official and shall have no relevance to his seniority position.
5. It should be ensured that there is no disciplinary/vigilance case pending/contemplated against them. If such case is pending/contemplated the facts may be reported to this office and the official should not be allowed the financial upgradation under MACP Scheme. It will further ensure that any punishment like withholding of increment etc. was current on the date of allowing financial upgradation. In that event also, the facts should be reported to this office immediately and the official should not be allowed the higher scale.
6. With regard to fixation of pay on grant of promotion / financial up gradation under MACP Scheme, a Government servant has an option under FR-22(1)(a) (1) to be exercised within one month from the receipt of this memo to get his pay fixed in the higher post/grade pay either from the date of his promotion / up gradation or from his next increment viz 1st July of the year. The pay and the increment would be fixed in accordance with clarification No 2 of Department of Expenditure 's O.M. No. 1/1/2008-1C dated 13.09.2008.
7. If a regular promotion has been offered, but was refused by the employee before becoming entitled to a financial upgradation, no financial upgradation shall be allowed as such an employee has not been stagnated due to lack of opportunities. If however, financial upgradation has been allowed due to stagnation and the employee subsequently refuses the promotion, it shall not be a ground to withdraw the financial up gradation. He shall, however not be eligible to be considered for further financial up gradation till he agrees to be considered for promotion again and the second and the next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.
8. MACP Scheme contemplates merely placement on personal basis in the higher pay scale/ grant of financial benefits only and shall not amount to actual / functional promotion of the above official. Since orders regarding reservation in promotion are applicable only in the case of regular promotion, reservation orders/ roster shall not apply to the MACP Scheme which shall extend its benefits uniformly to all eligible SC/ ST employees also. However, at the time of regular / functional (Actual) promotion, all reservation orders shall apply.
