Subject- Information regarding the purchase of Car. (Four Wheeler)

Sir,

In compliance of the circular letter No. 25/Admin (A) dated 13 July, 1998 of the Hon'ble High Court Allahabad, I am to inform that on 27th of May 2023 ,I purchase a Car (Suzuki Grand Vitara) Car No. UP 27 BJ2602 from Sumitra D.S. Motors Private Limited (Nexa Division) SH 25 Reti Road HONH 24 Roza bypass Sitapur Road Shahjahanpur (CIN: U50102 UP 2003 PTC 028060).

In regard to the Car purchase I am giving details of the following :-

- (A) Date of joining in the service -17.12.2019
- (B) Present Gross Salary is Rs 1,13,284/-. Present Net Salary at present being received Rs. 95,618.00/-.
- (C) I have not purchased any movable property before.
- (D) No loan has been secured from Hon'ble High Court Allahabad.
- (E) The total price of the Car is Rs. 15,60,000 /-for which I have taken loan of amount Rs. 13,00,000 from HDFC at interest rate 8.9%. The loan has been taken for 7 years whose per month installment that I have to pay is Rs. 20,994.00/-

(G) I do not have any personal relation with the dealer of the car nor any case is pending in my court.

(H) So far as income from where the amount of the car that of amount is Rs 15,60,000 /- is to be paid is as follows :-

(i) The total purchase price of the Car is Rs. 15,60,000/-

(ii) For purchase of the above car I have paid an amount of Rs. 11000/- to book the car from my salary account No. 6177000400003983 P.N.B. Janpad Nyaydhish Office Civil Court Compund, Allahabad.

(iii) Rs. 2,50,000 has been given to me by my husband Mohd Shahbaz Khan who is a Head- Special Initiatives and Business Strategy for Economic Times at Noida. The amount was transferred by my husband in my account from his salary account which was transferred through Net Banking to Sumitra D.S. Motors Private Limited.

(iv) The loan amount was Rs. 13,00,000/- and net disbursement is Rs. 12,95,807/- thus :-

- 11000/- (paid in cash) + 150,000 + 1,03,193 + 12,95,807 = Rs. 15,60,000/-.
