1. That, the deponent is a Citizen of India.

6. That, a warrant or summon for the appearance of the deponent or for the arrest of the deponent has not been issued by any court, under any law, for the time being in force or that any order prohibiting the departure of deponent from India, has not been made by any such court.
7. That, the deponent has not been repatriated.
8. That, the opinion of the Central Govt. the issue of a Passport or a Travel document to the deponent, will be in the public interest.
9. That, there is no possibility of arising any embarrassing position before the Hon'ble High Court, the entire Judicial Institution, the Govt. of India, or the Govt. of U.P. due to deponent's proposed visit to foreign countries.

That, during such proposed foreign visit, the deponent will not indulge in any such activity that may adversely affect in the International relations of the other country with the republic of India, or tends to tarnish the image of Hon'ble High Court, the entire Judicial Institution, the Govt. of India, or Govt. of U.P.
11. That, the deponent has never before visited any foreign country since hereto, he does not possess a passport and has never before applied for the same.
12. That, no criminal proceeding (in respect of any offence committed by the deponent) is pending before any Criminal Court in India.
