

Respected Sir,

I very humbly wish to submit that I took charge as Additional Civil Judge (Junior Division) in District of Amroha, Uttar Pradesh on 19-11-2019.

Prior to the date of taking charge, I got enrolled into LL.M Three year (Six Terms) Course with Faculty Of Law, University Of Delhi vide enrolment number DIT-101/07 and Roll No. 06161 in July 2018. Therefore, prior to taking charge, I completed attending three semesters successfully. Now only two semesters and dissertation remains to be completed.

In this LL.M. Three-year Course, only four classes per week are conducted in the evening in the university premises, i.e. either 5:30-7:30 pm, or 7:30-9:30 pm. This course was introduced to enable working persons to acquire the LL.M degree.

District of Amroha is situated at about 130kms from the said university. It takes around 2 hr 30 minutes travel time to reach there. If the Hon'ble Court is pleased to permit me to attend class having duration 7:30-9:30pm, then attending three such classes per week will enable me to fulfill the university attendance criteria. This way, I can complete LL.M course and also will be able to serve the Uttar Pradesh Judicial Services without any deficiency in service.

It is therefore humbly prayed to your good self to put up my application for the kind consideration of Hon'ble High Court of Judicature at Allahabad.

- That due to the effect of COVID-19 pandemic in the last academic session, all the students were promoted from year II to year III directly without conducting any exams vide the Faculty of Law notification dated 31-08-2020.
- 2. Further, classes of my current semester i.e Semester V, for two chosen subjects, i.e. Criminal Justice and Human Rights, and Comparative law of Marriage & Divorce and Civil code, were being conducted online in the evening slots only, post our working hours.
- The examination for the Vth semester (Remote mode) shall be conducted online.
- 4. It is also kindly stated that semester VI of my course (scheduled to begin in January 2021 and continue till June 2021), does not involve any engagement of classes per se, as the final or the semester VI is for submission of Dissertation work only and does not structurally require any engagement of classes. In respect of the captioned subject, with deep reverence, the undersigned officer very humbly wish to submit his detailed reply –

- 1. That between joining in the UP Nyayik sewa and Pre- COVID-19 period the undersigned officer attended evening classes only on the following dates physically in Faculty of Law, University of Delhi, and on no other date
 - a. In January 2020 10th, 13th and 27th January 2020,
 - b. In February 2020 3rd, 17th and 24th February 2020,
 - c. No physical class attended in March 2020.

That the supporting station leaves to travel to Delhi for aforementioned dates are attached with this letter, as **Annexure 3-1 to 3-6.** It is most humbly submitted that the undersigned officer completed his judicial work with utmost dedication on each day and then only went to attend LL.M classes to fulfill his dream of further education. Thereafter, the undersigned officer went to stay in his permanent address in Delhi and joined Court on the next working day.

- 2. This notice is attached herewith as **Annexure 3-7.** The classes were held online from 16-03-2020 in the evening time between 05:30PM to 09:30PM, which the undersigned officer attended in his residential premises in the station itself. Therefore, it is most humbly undertaken that from this date (16-03-2020) the undersigned officer was never required to travel to University of Delhi for attending any classes.
- 3. The classes for the subsequent Vth semester was also conducted online vide notice dated 28-08-2020 attached herewith as **Annexure 3-8.**

- 4. That the undersigned officer had appeared in the Vth semester examination in anticipation of permission of this Hon'ble High Court. This examination was held in Remote mode (Online) in an Open Book Examination (OBE) model, where the answer scripts can either be uploaded on a portal or emailed to the Nodal Officer from any location by the student and physical presence of the student at University campus is not needed. In this regard, the University guidelines detailing the OBE instructions and the examination form of the undersigned officer is attached herewith as **Annexure 3-9 and 3-10 respectively.** The result for this examination is attached herewith as **Annexure 3-11.**
- 5. That the VIth semester is dissertation where neither coursework nor examination is required to be conducted. The undersigned officer has not yet submitted his dissertation as the deadline for the same has been moved to 30th July 2021 vide Notice dated 28.05.2021, which is attached herewith as **Annexure 3-12.**
- 6. It is most humbly undertaken that studying the course of the LL.M study and the research done, has helped the undersigned officer to develop deeper understanding of the legal subjects and has never hampered in the performance of judicial work and duties in any manner. The undersigned officer would continue to steer his efforts towards service in the best possible way.
