Respected Sir. In respect of the captioned subject, with deep reverence, I very humbly wish to submit -1. That, earlier, the name of the undersigned officer was mentioned by the University in all the marksheets as "Jai Prakash Siddi" instead of "Siddi Jai Prakash" in all the marksheets of LL.M course. The old marksheets were - Part I Term I dated 23.04.2019 (issued physically), Part I Term II dated 20.08.2019 (issued physically), o Part II Term III dated 08.06.2020 (issued physically), o Term IV dated 06.12.2021 (issued online), o Term V dated 17.03.2021 (issued online), Term VI dated 25.11.2021 (issued online). 2. That the aforementioned old Term VI marksheet was declared vide Notification S.NO. NOT/2021/826 dated the 25th November 2021. A copy of these old marksheets are annexed herewith as Annexure 1-1 to 1-6. 3. That in order to get the correct name of the undersigned officer from "Jai Prakash Siddi" to "Siddi Jai Prakash" in all the LL.M records, an application was submitted to the Dean, Faculty of Law, University of Delhi. 4. That thereafter vide Notification number S.NO.NOT/2021/1765 dated 07.02.2022, the University of Delhi was pleased to notify that "in the Notification S.NO. NOT/2021/826 dated the 25th November 2021, regarding the result of above examination held in May/June 2021, the correct name of the undermentioned candidate be read as 'Roll No. 190504; Name of Candidate - Siddi Jai Prakash'; Marks obtained (Out of 1300) - 821 (Passed)." A copy of this notification is annexed herewith as Annexure 1-7. 5. Thereafter, the University of Delhi was pleased to issue the undersigned officer LL.M degree dated 26.02.2022 with the correct name - "Siddi Jai Prakash". But unfortunately, the name of the undersigned officer was not corrected in any of the marksheets of six semesters. 6. That in order to get the name of the undersigned officer corrected in all the marksheets, an application was again submitted to the Dean, Faculty of Law, University of Delhi on 12-08-2022. A copy of this letter is annexed herewith as **Annexure 1-8.** 7. That after accepting the application, the University of Delhi was pleased to issue the undersigned officer new LL.M marksheets with the correct name "Siddi Jai Prakash". 8. That since, the marksheets of first three semesters was generated physically, the date mentioned in the newly issued marksheets of part I term I, part I term II and part II term III got changed to 31.08.2022. Since, the marksheets of semester fourth, fifth and sixth were generated online, the date mentioned in those marksheets did not get changed. 9. That due to COVID-19 pandemic, the examination for the 4th semester were not held in time. They were held much later in the sixth semester. The marks obtained in the 4th semester examination was disclosed along with the result of the 6th Semester dated 25.11.2021. Subsequently, vide S.NO.AER/2021/335 dated 06.12.2021, the result of the 4th semester examination was released. A copy of this notification is annexed herewith as Annexure 1-9. This date 06.12.2021 is mentioned in the 4th semester marksheet. It is therefore most respectfully prayed that the Honourable High Court be pleased to pass an order to include LL.M degree in service records of the undersigned Officer.
