Respected Sir,

This is to submit that I have purchased a plot of Meerut Development Authority No. Q-199 Pallavpuram, Phase- 2, Meerut from seller Smt. Indu Singh W/o Shri Suresh Pal Singh & Shri Suresh Pal Singh on 22-02-2021 during the Corona period. My father wanted me to purchase this plot as it was near to his residence. The deal for purchase of this plot was done by my father for me. My father had suffered a heart attack and seriously ill at that time.

However, before we could collect the copy of sale deed, I was transferred to Balrampur after my taking of charge at Balrampur my husband got infected with Corona Virus and there after him I too got infected with Corona virus. I asked my father Shri Rajendra Singh who was residing at Meerut to collect the copy of sale deed. My father collected the same but soon after our recovery before we could collect the copy of sale deed from my father my mother too got infected with Corona virus. After recovery of my mother my father got infected with Corona virus who ultimately expired due to heart attack in December 2021. The copy of sale deed was with my father and before his death he could not inform us where it was kept. It was few days back when my mother was searching khatauni and other revenue paper of my father's ancestral property to change of her name in record that she found the copy of sale deed and informed me about the same.

So, it was due to unavoidable and unfortunate circumstances that I could not inform the Hon'ble Court about the purchase of said plot earlier. It is humbly requested to the Hon'ble Court to kindly give me ex-post facto permission for the purchase of the land and also it is most kindly and humbly requested to pardon me for same.
