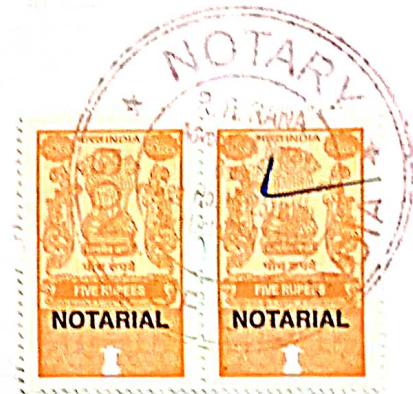

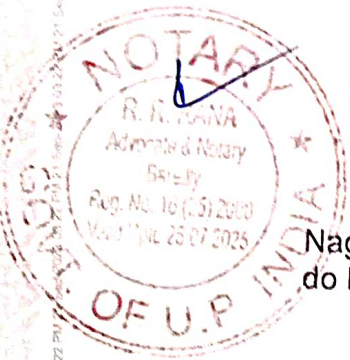

4. That the presence of deponent outside India is not likely to prejudice the friendly relation of India with any foreign country.

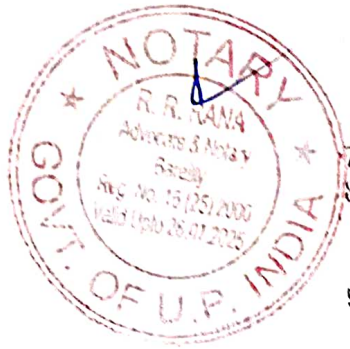

6. That a warrant or summon for the appearance of the deponent or for the arrest of the deponent has not been issued by any court, under any law, for the time being in force or that any order prohibiting the departure of deponent from India, has not been made by any such court.
