**Subject: Application for Permission to go abroad (Canada)- Reg**

Respected Sir,

It is humbly submitted that my son Harshdeep Singh has completed his graduation from a Canadian college and now he is working in Canada on a work permit and staying in a rented house at 9138 138B St. Surrey, BC, V3V 5T7 Canada. My wife Charanjeet Kaur is also working in Kelowna BC on work permit and residing at 1775, Swainson Road, Kelowna, BC V1P 1C5 BC, Canada. My daughter Simone Singh is studying in Queen Elizabeth Sec School Surrey, BC Canada in grade 11 and residing with her brother Harshdeep Singh. Thus, my family is living in Canada.

I want to go to Canada to visit my family in December 2023. My visit to Canada will not affect any judicial work because a link officer is appointed for every Court for such exigencies, and **I have strategically planned my trip so that the minimum working days of my court will get affected. The court will be closed from 23 December 2023 to 31 December 2023 due to 4<sup>th</sup> Saturday, Sunday, Christmas Day and winter holiday, and from 1<sup>st</sup> January 2024 to 21<sup>st</sup> January 2024, the court will also be closed for a significant amount of that time period.** According to Hon'ble High Court Circular No.- 16/ IV f -101/ Admin(A) dated 27.05.2017, abroad tour by any officer shall not be availed of during working days of court except in special circumstances. But my tour is not for pleasure. I have not met my family since July 2023. Being a father and husband, I also have to fulfil my responsibility toward my family. Coming back to India to meet me is not a viable option for my family as it will

jeopardize my son and wife's career and job, and study of my daughter also and there will be three times the financial burden on my family to come India and going back to Canada. So, it is necessary for me to visit Canada and spend some valuable days with my family for fulfil my responsibility toward my family in any way I can.

My family is staying in a rented house, and I will be staying with my son and daughter at 9138 134B St Surrey and my wife will come to my son's residence and will be staying with us for the duration of my stay. So, there will be no expenditure for accommodation. My visit to Canada entails only fare expenditure which is approximately about Two lac only. I am enclosing my bank statement for your kind perusal.

It is humbly submitted that in view of abovementioned special circumstances, I want to go to Canada from 23.12.2023 to 21.01.2024 after availing Earned Leave from 01.01.2024 to 20.01.2024 (with prefix fourth Saturday 23.12.2023, Sunday 24.12.2023, Christmas day holiday 25.12.2023 & winter holidays 26.12.2023 to 31.12.2023 and suffix with Sunday 21.01.2024). My proposed visit to Canada will be commenced on 23.12.2023.

It is also submitted that; I have visited Canada from 08.06.2019 to 19.06.2019 and 21.06.2023 to 23.07.2023 with the permission of Hon'ble High Court and came back within stipulated time and my previous request to travel to Canada from 02.05.2020 to 31.05.2020 was also approved but my flights were cancelled due COVID-19 pandemic and I could not go. I already applied for visa to visit Canada and the same was granted to me with validity till 01.10.2026. Therefore, I have valid visa to visit Canada. I am submitting my application before time because the air ticket may be available at cheaper rate.

**In light of Hon'ble High Court Circular No.- 16/ IV f -101/ Admin(A) dated 27.05.2017, I declare the following,**

- (a) That by my visit to Canada, no dilemma is likely to create before the Government of India or before the Government of UP.
- (b) That my any request to visit abroad was not refused to me earlier.
- (c) That I also applied for permission before Hon'ble Court to visit Canada from 08.06.2019 to 19.06.2019 and 21.06.2023 to 23.07.2023, the same was granted and I came back to India within stipulated time.
- (d) That my previous request to travel to Canada from 02.05.2020 to 31.05.2020 was also approved but my flights were cancelled due to Covid-19 pandemic and I could not go.

In view of abovementioned consideration, I humbly request to place my application before Hon'ble Court to kindly consider my application to allow me to visit Canada to meet my family. I shall be highly obliged.
