11. Detail of source of the amount with papers in support thereof.
- (a) Rs 5,22,000/ has been paid in Cheque by me the copy of Cheque no.689338 of S.B.I. bank Dated 11.09.2023 is attached herewith.
- (b) A loan of Rs 8,00,000/ as car loan has been taken from S.B.I. Town hall Branch Shahjahanpur, for a period of five years, The monthly installment of which is Rs16530/, which is to paid by me from my salary account. The above mentioned amount of Rs 8,00,000/ has been transferred through N.E.F.T. by S.B.I., town hall branch Shahajahanpur in the account of M/S Ambay Autocars Private Limited. 5th Km. Rampur Raod, C.B. Ganj. Bareilly (U.P) on dated 11.09.2023.
- (c) Applicant has paid to Dealer Rs. 5,22,000/- including registration fees, insurance and accessories. At the time of purchase of Vehicle applicant was told by the dealer that an amount of Rs. 1,16,712/- is being taken as registration fees of the Vehicle. The above mentioned amount was included in the total amount paid to the dealer by the applicant as is evident from the break up issued by the dealer. After the applicant paid the said amount, the applicant applied for BH series registration number of her Vehicle. For BH series registration, as per the government regulation the whole registration fees is not taken as lumpsome at the time of purchase of vehicle. Instead, the fees is taken in installments, for which only Rs.12,700/- is to be paid as the first installment. After deductiong the above amount of Rs.12,700/- from the total registration fees of Rs. 1,16700/-, that the applicant has, paid earlier, an amount of Rs.1,04,000/- was refunded to the applicant's account through N.E.F.T. by the dealer. The above maintioned all the transations have been shown in the breakup statement issued by the dealer.
