
Sir,

II. I will not engage in activities prejudicial to the sovereignty and integrity of India.

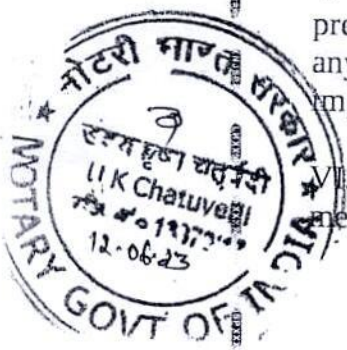
III. My departure from India will not be detrimental to the security of India.

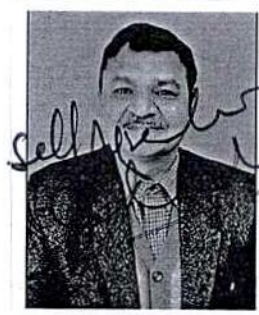
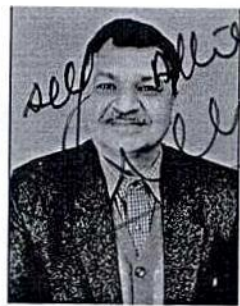
