Most respectfully I want to bring to your kind notice that I am a Judicial officer of 2003 batch of PCS (J) and presently I am posted as ADJ at Moradabad.

Further it is submitted that I was a research fellow of UGC, before joining the judicial service and I have also earned a Ph.D. in International law on World Trade Organisation with the prior permission of Hon'ble Court. Besides that I also studied elementry German and Urdu languages in the University.

Keeping in view my academic background and my experience in Judiciary, my college friend Prof. Gous Mashkoor Khan (Founder professor of Trukish language Dept. at JNU, New Delhi.), had recommended my name for a courtsey visit and small group discussion to be held at Selcuk university in konya (Turkiye). Now pursuant to the recommendation of Prof. Gous Mashkoor Khan I have received an invitation to visit Selcuk university in Konya- (Turkiye) and I am keenly looking forward to visit the University during the period mentioned in the invitation letter i.e. from 22 December 2023 to 10 January 2024. After visiting Selcuk University I wish to visit Athens (Greece) in Schengen Zone preferably by train. I have a vaild passport and I will apply for Visa, as soon as I recieve the permission from the Hon'ble Court.

Further it is submitted circular Letter No. 16/Ivf-101/Admin(A), Dated 27.05.2017 of Hon'ble Court mandates that Judicial officers won't go abroad on pleasure tours during working days except in special circumstances. Although my proposed tour is not fully a pleasure trip, but I have planned my tour very carefully so that my judicial and administrative work may not get affected adversely. I suppose to complete my tour programme during winter vacation i.e. from 24 December 2023 to 31 December 2023 along with 2-3 casual leaves, as the duration of my tour would be approx 10 days. As regards working days I have to submit that a link officer is already designated in the District for every Court to deal with important work in the absence of concerned judicial officer.

Approximate travel cost of my tour would be around Rs. 1.50 lakh as major period during my tour, I would stay at the University guest house, and besides Airfare I will have to spend bare minimum on other necessities. I have sufficient money in my bank account to bear the expenses of the tour as I have received the pay commission arrear in September, 2023. Further in the light of Hon'ble High Court's Circular Letter No. 16/Ivf-101/Admin(A), Dated 27.05.2017. I declare that I have never made any request to visit abroad nor my request to visit abroad has ever been refused earlier and also that by my visit to Turkiye & Greece, no dilemma is likely to occur before the Govt. of India or before the Govt. of U.P.

I assure the Hon'ble Court that my tour programme in no way will adversely affect the judicial and administrative duties assigned to me and also I won't indulge any such activity which may adversely affect the image/or security of nation.
