1. That am an Indian citizen holding a valid Indian passport with passport number **L6756244**, issued on 09.01.2014 by the Government of India,

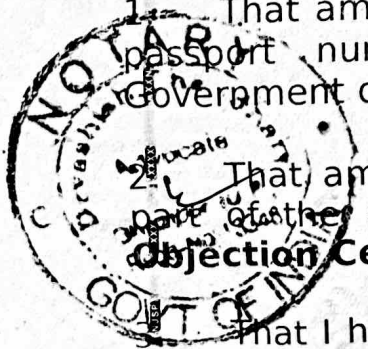
2. That, am desirous of renewing my existing passport, and as part of the application process, I am required to submit a **No Objection Certificate (NOC)** with the passport authorities,

7. That I will provide all the necessary and accurate information in my passport renewal application and the supporting documents attached therewith,

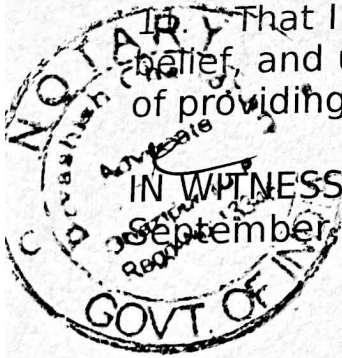
8. That I do not have any objections to the renewal of my passport, and I authorize the concerned passport authorities to proceed with the renewal process,

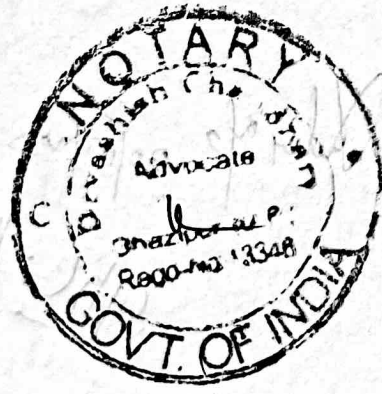
