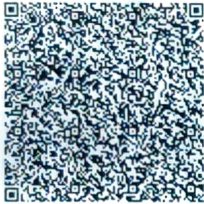

Declarations as per section 6(2) of the passport act, 1967

- (a) that the a applicant is a citizen of India;
- (b) That the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- (c) that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India;
- (d) that the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India,
- (g) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court,
- (h) that the applicant has not been repatriated.
- (i) that there is not any possibility of arising embarrassing position before Government of UP due to applicant's visit to any foreign country.
- (j) that such type of request regarding issue of 'Identity Certificate' for obtaining a passport was not refused to the undersigned earlier.
- (k) that the applicant has not visited any country earlier.
