- 11- That I have previously visited foreign country(Qatar) in 2018 and obtained the Visa on Arrival before the joining of Judicial Service.

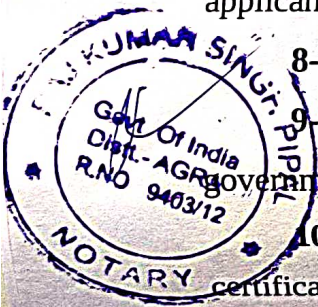
