Sub: Regarding correction in the date of issuance of LL.M. Degree of Sushri Isha Chaudhary, Civil Judge (Junior Division), Shamli at Kairana.

Sir,

With reference to above mentioned subject, I am to say that verification report along with clarification was sought from Chaudhary Charan Singh University, Meerut, vide Court's letter no. 3304/IV-4750/Admin.(A1) dated 02.03.2023, in the matter of Sushri Isha Chaudhary, Civil Judge (Junior Division), Shamli at Kairana on the below mentioned queries :-

1. Date of issuance of 1st, 2nd and 3rd semester mark-sheet is of one common date i.e. 07.05.2019 (copy enclosed)
2. Date of issuance of 4th semester mark-sheet is of 26.03.2019, which is issued earlier than remaining three semesters (copy enclosed).
3. Lastly, date of issuance of LL.M. Degree is 24.09.2018, for the examination year 2018, which was also issued earlier than mark-sheets of all the four semesters (copy enclosed).

In response to which, the reply furnished by Registrar, Chaudhary Charan Singh University, Meerut, vide letter no. Conf./1301 dated 08.08.2023 on query no. 1 & 2 was found true and correct by the office of Hon'ble Court, whereas the reply furnished by the University on query no. 3 in itself has raised some uncertainty by the University. **As per the University's reply on point no. 3, it says that Chaudhary Charan Singh University, Meerut has mistakenly printed the wrong date of issuance on the Degree of Sushri Isha Chaudhary, which needs to be get corrected/modified by the University on the request of concerned candidate. Thereafter, the University, only after correcting the date of issuance of Degree, will be able to furnish the verification report of Sushri Isha Chaudhary to the office of Hon'ble Court.**

I, therefore, to request you to kindly ask Sushri Isha Chaudhary to contact Chaudhary Charan Singh University, Meerut for the correction in the date of issuance of LL.M. Degree and submit the attested copy of corrected Degree, through online eServices portal for Judicial Officers, which is mandatory for sanction of three advance increments, before the office of the Hon'ble Court for further necessary action.
