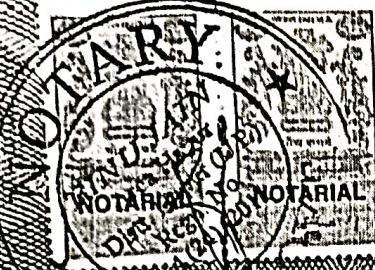

- (f) That proceedings in respect of any offence alleged to have not been committed by applicant are pending before a criminal court in India.
- (g) That a warrant or summons for appearance, or a warrant for the arrest of the applicant has not been issued by a court under any law for the time being inforce or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- (h) That the applicant has not been repatriated.
- (i) That there is no possibility of arising embarrassing position before the Govt. of U.P. due to my visit to any country.
- (j) That issuance of 'Identity Certificate' for obtaining a passport was never refused to me.
- (k) That I have not visited any foreign country till now.
