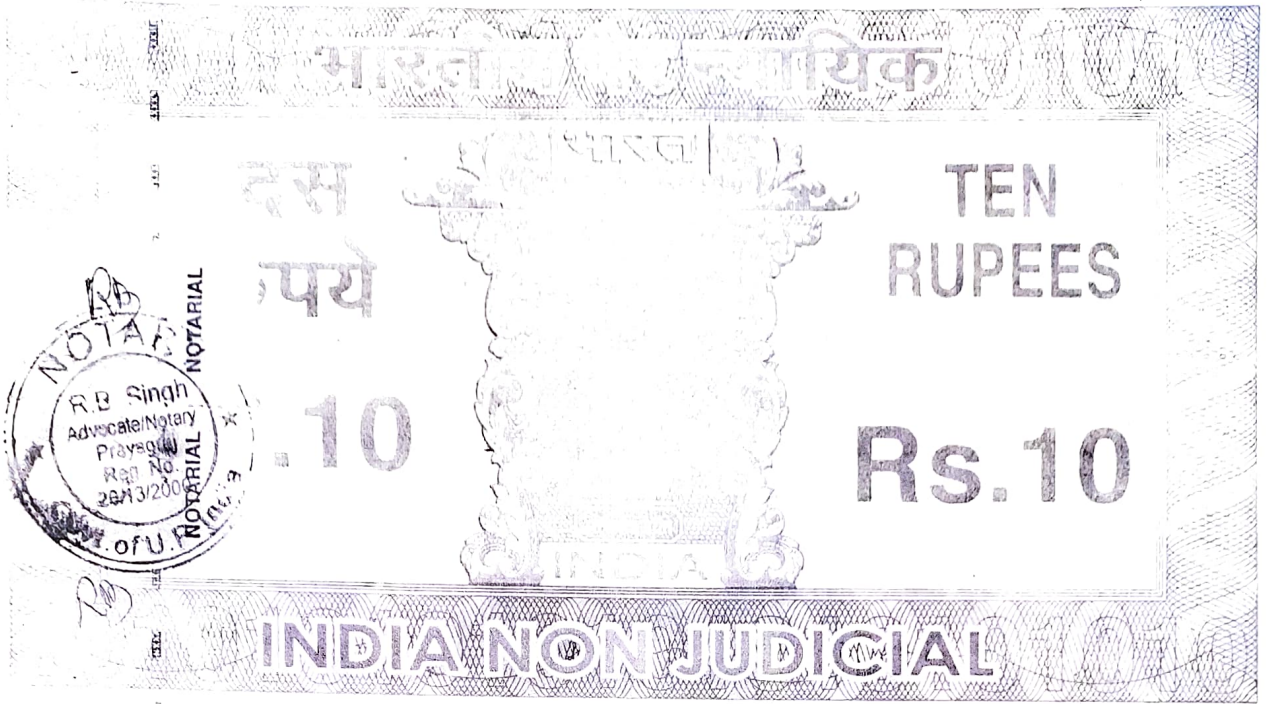

AFFIDAVIT

1. That the deponent is a citizen of India.
2. That the deponent may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
3. That the departure of the deponent from India may not, or is not likely to be detrimental to the security of India.

10. That issue of 'Identity Certificate' for obtaining a passport was never refused to the deponent.
11. That deponent has never visited any foreign country earlier.
