

5. That the deponent has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
6. That proceedings in respect of any offence alleged to have not been committed by the deponent are pending before a criminal court in India.
7. That a warrant or summons for the appearance, or an warrant for the arrest, of the deponent has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the deponent has not been made by any such court.
8. That the deponent has not been repatriated.
9. That, there is no possibility of arising embarrassing position before Government of U.P. due to deponent's visit to any foreign country.
10. That issue of 'Identity Certificate' for obtaining a passport was never refused to the deponent.

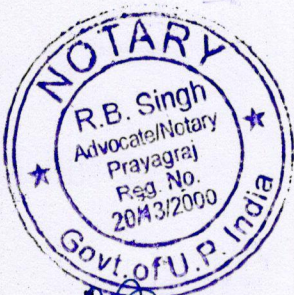


