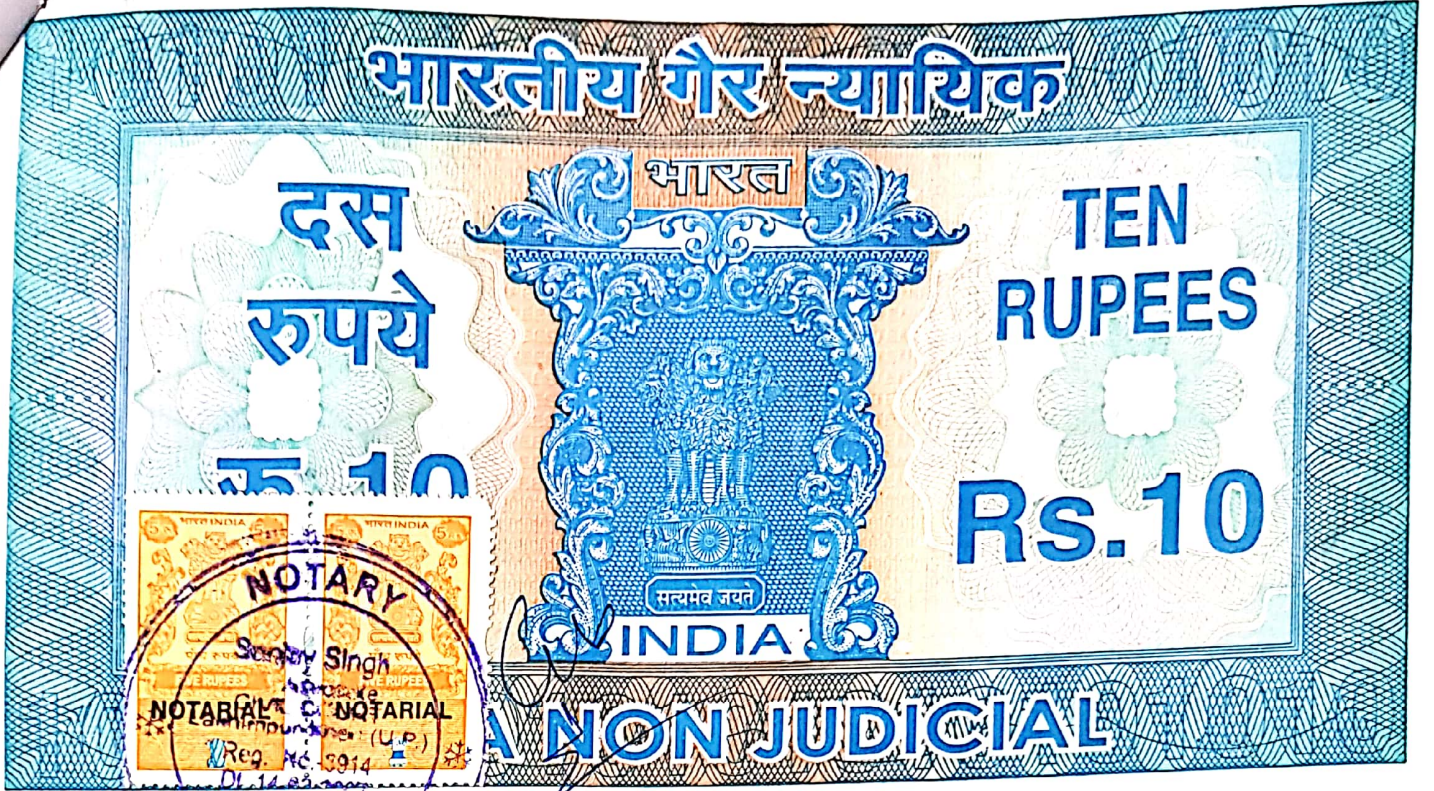

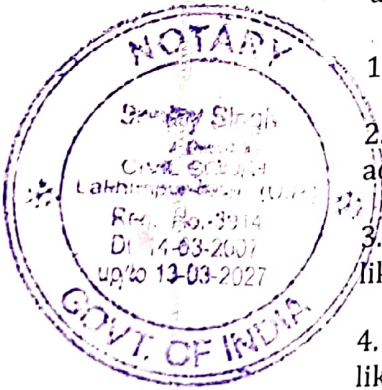

9. That, there is no possibility of arising embarrassing position before Government of U.P. due to deponent's visit to any foreign country.

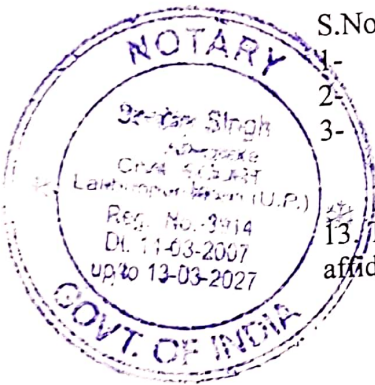
10. That, issue of 'Identity Certificate' for obtaining a passport was never refused to the deponent.


