I want to furnish the following information in the light of the **Circular Letter No. 25/Admin. (A) dated 13th July, 1998** issued by the Hon'ble High Court of Judicature at Allahabad.

Sir, I want to submit that-

- I joined the Uttar Pradesh Judicial Services on 05th January 2024 vide notification No. 70/ Admin. (Services)/ 2024 dated 04th January 2024.
 (Pursuant to U.P government notification/ appointment No. 1192/ DO -4-2023 dated 04.12.23).
- 2. My present gross salary is Rs. 1,16,396 (One lakh sixteen thousand three hundred ninety-six rupees) (during the month of February) and since the undersigned has recently joined the services therefore no deduction of NPS and income tax has been considered yet. Thus, the take home salary is equal to the gross salary.

 - Sir, the total price paid by me for the purchase of above mentioned car was Rs. 16,99,000(Sixteen lakhs Ninety-Nine Thousand Rupees). And, the Registration Number of the car is "UP-26-AS-5034".
- 4. I have not taken any advance or loan from the Hon'ble High Court.
- 5. I took a car loan of Rs. 13,99,000 (Thirteen lakhs Ninety-Nine Thousand Rupees) from the State Bank Of India, ADB Branch, Sitapur to pay the complete amount to the dealer. The loan account no. for the same is 42706941569.
 The loan EMI's are payable for 84 months (7 years) at Rs. 22,830 (Twenty-two thousand eight hundred thirty rupees). (Shown in Annexure)
- 6. I have purchased a new car.
- 7. The property purchased was a movable property of the description mentioned in point no. 3.
- 8. I have purchased the above mentioned car from the reputed dealer MOSARAM ENTERPRISES LTD, having its registered address LRP ROAD LAKHIMPUR KHERI. I purchased the vehicle from the dealer's Sitapur branch having the branch address LUCKNOW HIGHWAY JAMAIYATPUR KHAIRABAD SITAPUR.
- 9. Yes, the dealer is well known, reputed and regular MAHINDRA car dealer of Sitapur.
- 10. No, the dealer is nowhere related to me and I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.
- 11. The amount for the purchase of above-mentioned car was paid in the following manner:



A) Sir, My father has gifted me an amount of Rs. 2,10,000 (Two Lakh Ten Thousand Rupees) through a consent letter dated 15.02.2024 for the purpose of purchasing this car. In which a total amount of Rs. 1,60,000/- (One Lakhs Sixty Thousand rupees Only) were directly transferred to my account.

And, 25000 (Twenty five thousand Rupees) paid in advance from my father's account to MOSARAM ENTERPRISES LTD. (dealers account) dated 14 February 2024 using IMPS (Ref. number 2024021480487713).(Shown in Annexure)

And, Rs. 75000 (Seventy-five thousand Rupees) paid from my brother's account to MOSARAM ENTERPRISES LTD. (dealers account) (which includes transfer of 25000 from father's account and 50000 from my account) dated 14 February 2024 using UPI (Ref. No. 441137880761) (Shown in annexure).

- B) Rs. 1,50,000 (One lakh fifty thousand Rupees) paid from my Savings Bank account No. 35331020192 (in 3 instant transfers of Rs. 50,000 and 25,000 using debit card & Rs. 75,000 using UPI, Ref. No. 404648373713) dated 15 February 2024.(Shown in Annexure).
- C) Rs. 50,000 (Fifty thousand Rupees), were paid as Over Draft from State Bank Of India, ADB Branch, Sitapur, dated 16 February 2024.
- D) A Car loan of Rs. 13,99,000/- (Thirteen lakhs Ninety Nine thousand Rupees) was taken from the State Bank Of India, ADB Branch, Sitapur, to pay the remaining amount to the dealer.

- B. Delivery challan (Gate Pass) issued by the dealer.

- **D.** The Statement of Loan taken by me from the aforesaid branch of the State Bank of India, ADB Branch Sitapur.
- E. The Registration Certificate issued by RTO, Pilibhit regarding the purchased vehicle.
