Most humbly this is to inform that I have purchased a <sup>new</sup> car Hyundai i10 Era. Information in regard to the purchase is being furnished as required by C.L. No.25/admin (A) Dated 13<sup>th</sup> july 1998, as under :

- 1.Date of Joining of service: 16<sup>th</sup> june 2006
- 2.Present Drawn Salary is Rs. 24835 only, and take home salary after deductions is Rs.23135 only.
- 3.Details of purchase earlier exceeding Rs. 10,000: Earlier no purchase of movable and immovable property above ten thousand rupees done after joining the present service.
- 4.No advance or loan taken from Hon`ble High court
- 5.Loan taken from State bank of India Bidhuna Branch Auraiya.  
Loan Amount Rs 347000.The loan amount is refundable in 84 equated monthly instalments of rupees 5761, only, starting from november 2009. The period of deduction is 7 years. Out of entire loan amount Rs347000, a sum of Rs 3965 has been sanctioned by the bank concerned to cover the loan amount under SBI Life Insurance. The actual amount of car loan is Rs 343035 to purchase the car.
- 6.No second hand car has been purchaed.

7. No information is required to be submitted as the property acquired by me is of movable nature.
8. I have purchased a new hyundai i 10 Era car from authorised dealer of Hyundai Motors India Ltd. At Kanpur namely M/S Tirupati Services Limited, 84/105. G.T. Road Kanpur.
9. The Dealer concerned is a regular and reputed distributorship duly authorised by the concerned automobile company.
10. The Dealer/seller mentioned above is not related to me in any way and no case against the dealer/seller is pending with my court nor any case has been decided by me.
11. To acquire the abovementioned new Hyundai I 10 car a sum of total rupees 373035 has been paid to the dealer. Rs 343035 received from Bank Loan and rest rupees 30000 paid by me through cheque from my salary account. Relevant papers regarding sanction of loan for purchase of vehicle, insurance covernote and certificate of registration etc. for kind perusal of Hon`ble High Court are being enclosed.
