**Subject-** Submission of information/ intimation regarding the purchase of movable property (Car) in accordance with the Rule 24 of the Government Servants Conduct Rules 1956.

Respected Sir,

I want to furnish the following information in the light of the **Circular Letter No. 25/ Admin. (A) dated 13<sup>th</sup> July, 1998** issued by the Hon'ble High Court of Judicature at Allahabad. Sir, I want to submit that-

1. I joined the Uttar Pradesh Judicial Services on 15<sup>st</sup> November 2019 vide notification No. 4015/ Admin. (Services)/ 2019 dated 14<sup>th</sup> November 2019.
2. I was getting a Gross Salary of Rs. 84,188/- (Eighty four thousand one hundred eighty eight rupees) during the Month of October/November, while the Take Home salary was Rs. 70,675 (Seventy thousand six hundred seventy five) at that period.
3. I have purchased a new car on 31.10.2020 named 'Kia Sonet HTK+ (1.2 5MT)' from its dealership showroom 'ASB Automobiles (Pvt.) Ltd.' located at Industrial Area, Sector-22 Meerut Road, Ghaziabad'. Sir, the total price paid by me for the purchase of above-mentioned car was Rs. 9,51,316/- (Nine lakh fifty one thousand three hundred sixteen).
4. I have not taken any advance or the Loan from the Hon'ble High Court.
5. I took a Car Loan of Rs. 6,00,000/- (six Lakhs) from the State Bank of India, Aligarh Main Branch to pay the complete amount to the dealer. The Loan Account No. for the same is **39766885857**. The Loan EMIs are payable for 48 month (4 years) at Rs. 14,600/- (Fourteen thousand six hundred Rupees)/monthly. **(Shown in Annexure)**
6. I have purchased a new car.
7. The property purchased was a movable property of the description given in Point No. 3.
8. I have purchased the above-mentioned car from the reputed dealer "ASB Automobiles (Pvt.) Ltd., having its **registered address**-Plot No.- C-1/2, Industrial Area, Sector-22 Meerut Road, Ghaziabad-201009. I purchased the vehicle from the abovementioned dealer at Ghaziabad.
9. Yes, the dealer is well known, reputed and regular Kia Car dealer of Ghaziabad.
10. No, the dealer is nowhere related to Me. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.
11. I have made all the payments towards purchasing of the said vehicle from my Saving Bank Account No. 30714508352 of State Bank of India. The whole amount was paid in following manner:-
  - (i) Rs. 25,000/- (Eleven Thousand Rupees) paid as Advance Booking Amount.
  - (ii) One Transfers of Rs. 3,49,000/- (Forty-Nine Thousand) were made through Cheque (no.000847) dated 30-10-20. **(Shown in Annexure)**

- (iii) A Bank transfer of Rs. 6,00,000/- (Six Lakhs Rupees) was made by the bank on my instructions from my Loan Account No. **39766885857** to the Dealer's account on dated 31.10.2023. **(Shown in Annexure)**
- (iv) A Car Loan of Rs. 6,00,000/- (Six Lakhs Rupees) was taken from the State Bank of India, Aligarh Main Branch to pay the remaining amount to the dealer. **(As mentioned in Point No. 5 above)**




