The development of a legal system and its processes is a *sine qua non* for the sustainable growth of industry, society, and public policy. One of the core tenets of any such evolved legal system is dispute resolution. Conventionally, the practice of litigation before courts of law involved inflexible proceedings and lengthy courtroom exchanges, often to the detriment of the parties to the dispute. Consequently, the widespread use of alternative dispute resolution mechanisms can be observed in both domestic and international business. Legal professionals across industries are expected to possess a nuanced understanding of not just traditional private law, but also processes such as commercial mediation, domestic and international arbitration, investor-state dispute resolution, and enforcement of settlements and arbitral awards through domestic courts.

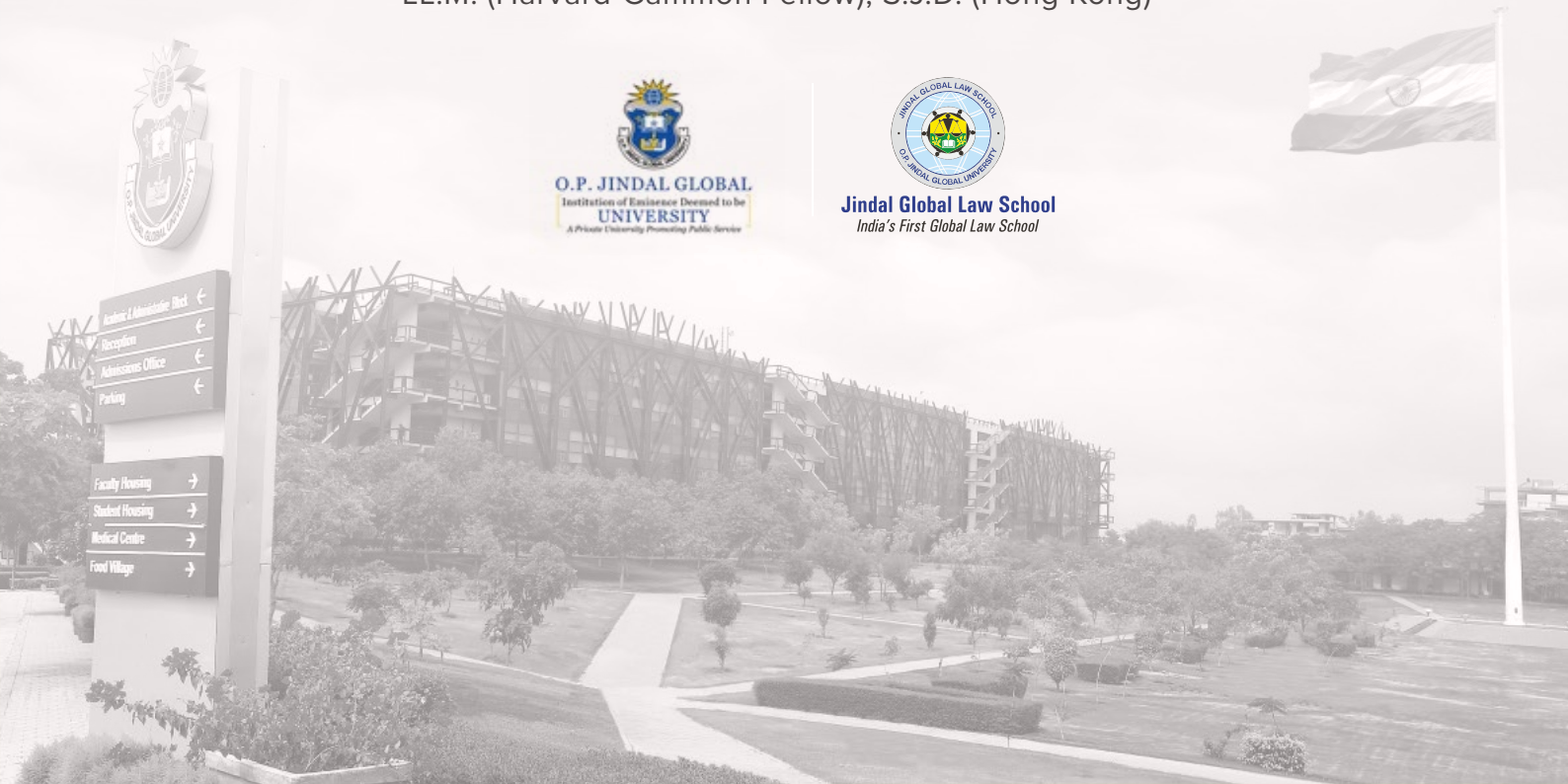

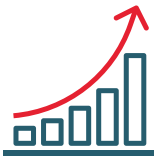
