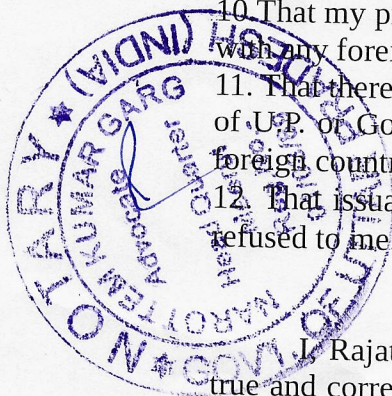


ANNEXURE '1'

AFFIDAVIT

I, Rajat Singh Jain S/o Late Sri Narendra Singh Jain, resident of District Judge Residence, Civil Lines, Meerut, date of birth 19.06.1968 being an applicant for issuance of passport, do hereby solemnly affirm and state on oath as under: -

1. That the names of my family members are:
 - (i) Wife : Smt. Apurva Shree Jain (D.O.B. 01/7/1975)
 - (ii) Minor son : Abhijay Singh Jain (D.O.B. 10/2/1999)
 - (iii) Mison daughter : Devanshi Jain (D.O.B. 03/7/2002)
2. That I am continuously resident of the aforesaid house for more than last one year.
3. That I am citizen of India by birth and that I have neither acquired the citizenship of another country nor have surrendered or been terminated/deprived of my citizenship of India.
4. That I have not, at any time during the period of five years immediately preceding the date of this affidavit, been convicted by any court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
5. That no proceedings in respect of any criminal offence alleged to have been committed by me or are pending before any criminal court in India.
6. That no warrant or summons for my appearance and no warrant for my arrest, has been issued by a court under any law for the time being in force, and that my departure from India has not been prohibited by order of any such court.
7. That I have never been repatriated from abroad back to India at the expense of Government of India or in any other manner.
8. That I and my family members will not engage outside India in activities prejudicial to the sovereignty and integrity of India.
9. That my departure from India will not be detrimental to the security of India.
10. That my presence outside India will not prejudice the friendly relations of India with any foreign country.
11. That there is no possibility of arising embarrassing position before Government of U.P. or Govt. of India due to my visit and that of my family members to any foreign country.
12. That issuance of 'Identity Certificate' for obtaining a passport has never been refused to me.
