Respected Sir,

Most respectfully, my humble submission in response to the Hon'ble High Court, Allahabad Letter No.3314/IV-5488/Admin (A-4) dated 14-03-2024 is, now that I had been registered as a user on the e-services portal, I am submitting a fresh application through the above-mentioned portal regarding permission to pursue LL.M. course from Aligarh Muslim University as per the directions of the Hon'ble High Court Letter No. 558/XXXIII-CPC/e-Courts/Allahabad/Dated: 31 August 2019. I humbly submit that I took admission and had been pursuing my LL.M. course from Aligarh Muslim University since the year 2022, that is, before joining UP judicial services. I have passed all three semesters positively prior to my joining in the service. The copies of the marksheets of all three semesters and the copy of the admission card of my LL.M. program are enclosed herewith.

It is further most humbly submitted with regard to the fourth and the final semester, the attendance requirements have been fulfilled prior to the joining of the service, what remains is only the exams of fourth semester for which no study leave is required. The examinations are likely to be conducted by the University in the third week of May, 2024, but the detailed program/schedule for the same has not been released yet. Regarding the dissertation submission, no such class activity is required and the same shall be completed by me in the spare time before and after the working hours of the Court as also in holidays.

I most humbly submit that according to Hon'ble High Court Allahabad, C.L. No. 35/IV-h-16/Admn.(A), dated 04.11.2011, if any judicial officer during the course of his/her service, requests to pursue his/her higher studies, he/she has to apply for grant of 'Study leave', I humbly submit that I do not require any study leave but only the permission of the Hon'ble Court to appear in LLM (fourth semester examinations) for which casual leave of 4-5 days shall be sufficient.


Most respectfully, I request your good self to kindly place my request before the Hon'ble High Court to grant me the permission to appear for the fourth semester examinations of LL.M. course and for the submission of dissertation.

I, very humbly assure the Hon'ble Court that my pursuing of remaining exams of LL.M. course, shall in no manner come in the way of performing the judicial work by me. I shall be highly obliged to the Hon'ble Court for its kind consideration.
