
It is, therefore requested that the aforesaid application may kindly be placed before The Hon'ble Court for kind consideration.

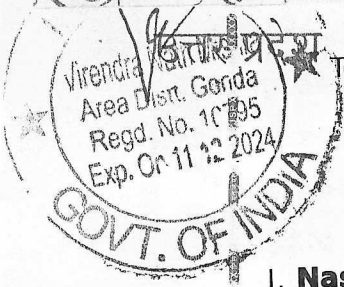

- (n) that the facts mentioned above are true according to my personal knowledge.

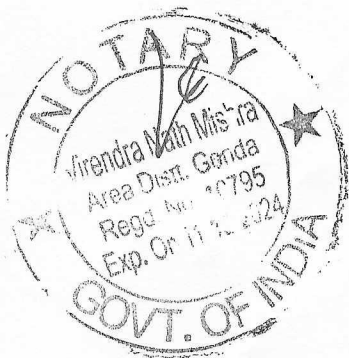

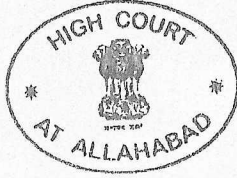

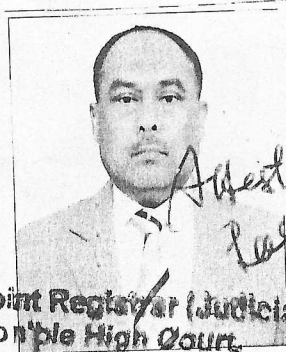




IDENTITY CERTIFICATE
