The concept of intellectual property (IP) has evolved with the development of a legal system. It ensures the enforcement of proprietary rights in technological innovation in contemporary times. This led to the drafting and signing of national and international laws, conventions, and treaties for the global protection of IP in an increasingly connected and inter-dependent global business landscape. India has been a member of the World Intellectual Property Organization since 1975 and signed the TRIPS agreement in 1994 to align its IP law regime with international standards. India's endeavour for widespread enforcement of IP law can be demonstrated by its adoption of a National Intellectual Property Rights (IPR) Policy in 2016, setting the roadmap for a creative and innovative India.

The policies, laws, conventions, and practices of IP enforcement is underscored by the emerging technology markets of the 21st century. With the advent of the Internet of Things (IoT), machine learning and the evolution of artificial narrow intelligence has changed the realm of intellectual property in the last two decades. Knowledge-based economies driven by information have transcended tangible and conventional boundaries of property. Since such technological growth holds the key to the future, it is imperative that a dynamic legal framework for its regulation be developed and that legal professionals trained to address novel and complex IP issues be at the helm of affairs.

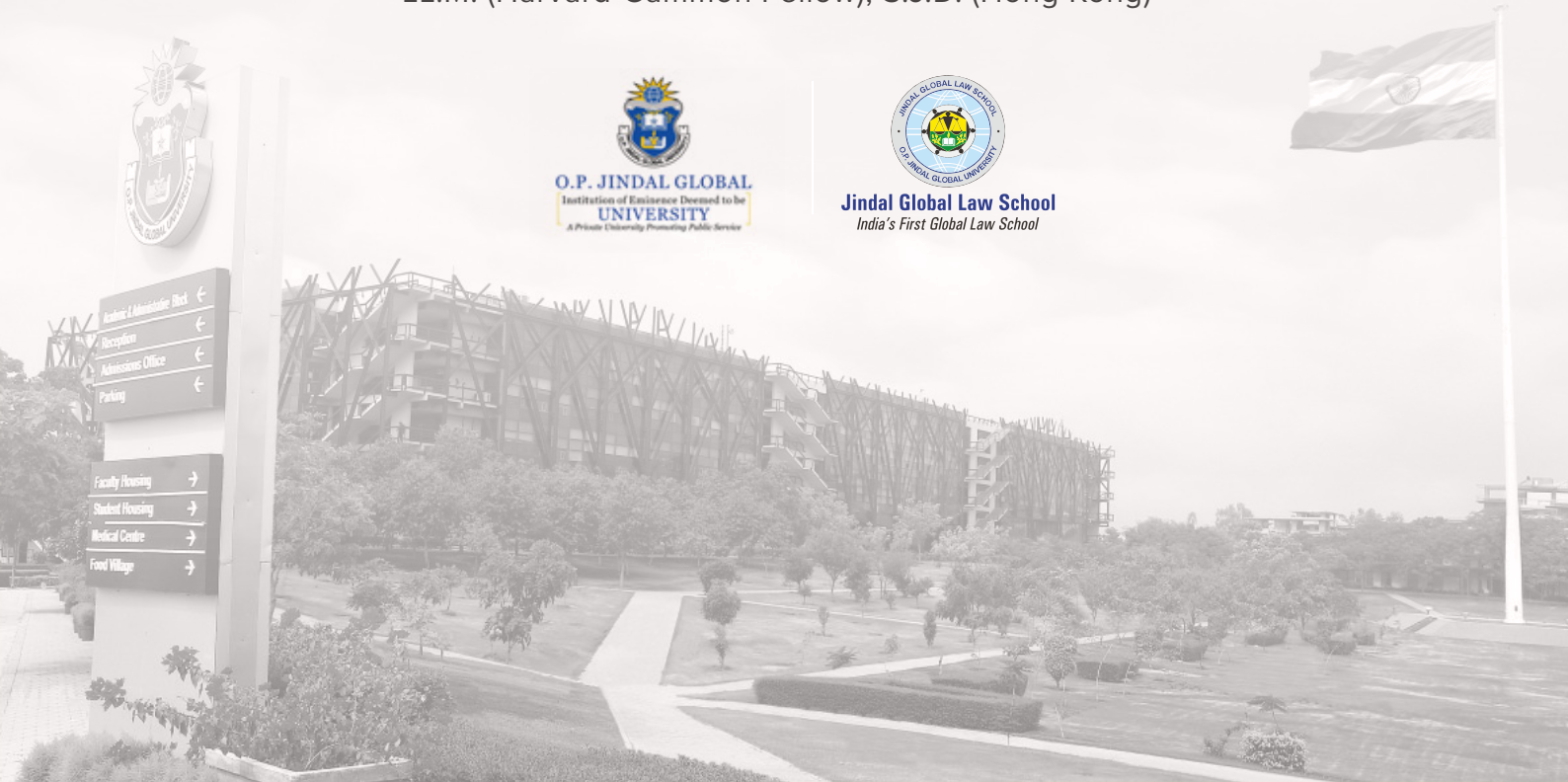

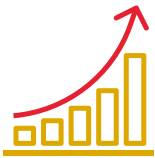

Second Trimester

COURSE 4 (4 Weeks)

ADVANCED IPR AND IT LAW

This advanced course on Intellectual Property and Cyber Laws is built on the foundations of IPRs taught in the undergraduate program. The present course will delve into different perspectives of intellectual property rights and concerns of the developing countries in relation to international transfer of technology. The course aims to provide participants an insight into the intellectual property issues in the digital medium. It explores trademark concerns in cyberspace that take the form of domain names and the disputes arising from such concerns. The liability of service providers under the Information Technology Act will also be in this context.

COURSE 5 (4 Weeks)

INTELLECTUAL PROPERTY AND NEW TECHNOLOGY, AI

In this course you will study about the nature of IP Law in the context of new technologies. You will learn about the theoretical complexities created in IP law and policy by changes in technological paradigms, important legislative and judicial positions across jurisdictions and larger socio-economic implications of these changes.

COURSE 6 (4 Weeks)

MUSIC AND COPYRIGHTS

This course seeks to provide a thorough understanding of copyright law in musical works. It introduces students to the economic analysis of the music industry and the justifications for copyright in musical works. It enables students to understand the different rights that an owner of musical works can exercise and the possible ways through which revenues can be maximized. Digitalisation of music poses problems like unauthorized file-sharing and concerns about digital piracy which results in loss of revenue to copyright owners. This course will aim to understand the complexities involved in the dissemination of musical work through digital platforms as well as address issues like moral rights and copyright infringement.

Third Trimester

COURSE 7 (4 Weeks)

INTERNATIONAL INVESTMENT LAW AND INTELLECTUAL PROPERTY

Under international law, there are several treaties that protect IP. However, in recent years, bilateral investment treaties (BITs) and investment chapters in free trade agreements (FTAs) - the most important source of international investment law (IIL) - have emerged as important instruments for the protection of IP because these treaties recognize IP as a protected investment. Through the investor-State dispute settlement (ISDS) mechanism, these treaties empower foreign investors to sue the host State's IP-related regulatory measures as treaty breaches. This course would study the interactions and interrelations between the IIL regime and IP.

- Evolution of the IIL regime to enable protection of IP rights under international law
- Significance and consequences of IP as a protected investment in BITs and FTA investment chapters
- Evaluation of IP-related regulatory measures (such as compulsory licensing) liable to challenge by foreign investors before ISDS tribunals
- Relative and absolute standards of an investment treaty, used by foreign investors to challenge IP-related regulatory measures
- Relationship between the IIL regime and other international law instruments on IP, such as the TRIPS Agreement
- Evolving treaty practice of States on IP within the IIL regime

COURSE 8 (4 Weeks)

TRIPS AND PUBLIC HEALTH

Public health has taken center stage in international law and policymaking in the era of COVID-19. This course will offer a window into the interrelation between intellectual property and globalization in context of the long running theme of global public health. The course mainly focuses upon how international legal rules and arrangements about IP rights, especially since the beginning of the TRIPS-era, have been crucial in constituting frameworks for managing this important aspect of our globalized society. To achieve this, the course will provide a bird's eye view to the study of intellectual property globalization covering the major legal, political, and historical aspects. The course would also incorporate relevant discussion on the contemporary issues related to IP and Covid-19 pandemic.

- **Evolution of International IP Law and Policy in context of Global Public Health**
- **Basics of International IP Regime including treaties, agreements (TRIPS, Doha Declaration, Paris Convention, Bilateral Investment Treaties) and international institutions (WTO, WIPO, WHO, etc.)**

- IP-trade linkage issues (IP and International Economic law) and its impact on Global Public Health outcomes
- Flexibilities within Intellectual Property globalization (Compulsory Licensing, Anti-evergreening Patentability Standards, etc.) as well as alternatives to the current framework (Open Science, Patent Pooling, Prizes, etc.)
- Role of IP laws in issues of Equitable Access and Social Justice that shape the current discourse as part of the wider debate about Global Public Health

COURSE 9 (4 Weeks)

GDPR: A EUROPEAN EXAMPLE OF DATA PROTECTION LAW

General Data Protection Regulation or GDPR is a robust data protection law across varied jurisdictions. In this course, you will learn in greater detail about the nuances concerning GDPR and what it is likely to entail for those engaged in the processing of personal data. The use of case studies and judgments pronounced by the Court of Justice of the European Union will help understand the objectives that the GDPR intends to fulfill.
