Respected Sir,

It is humbly submitted that my son Harshdeep Singh is working in Canada on a work permit and staying in a rented house at 9138 134B St. Surrey, BC, V3V 5T7 Canada. My wife Charanjeet Kaur is also working in Kelowna BC on work permit and residing at 1775, Swainson Road, Kelowna, BC V1P 1C5, BC, Canada. My daughter Simone Singh is studying in Queen Elizabeth Sec. School Surrey, BC Canada in grade 11 and residing with her brother Harshdeep Singh. Thus, my family is living in Canada. It is necessary to mention here that there is a free education till class 12th in Canada.

I want to go to Canada to visit my family in August 2024. My visit to Canada will not affect any judicial work because a link officer is appointed for every Court for such exigencies, and I have strategically planned my trip so that the minimum working days of my court will get affected. The court will be closed 04/08/2024 (Sunday), 10.08.2024 (Second Saturday), 11.08.2024 (Sunday), 15.08.2024 (Independence Day), 18.08.2024 (Sunday), 19.08.2024 (Local Holiday), 24.08.2024 (fourth Saturday), 25.08.2024 (Sunday,) 26.08.2024 (Janmashtami). According to Hon'ble High Court Circular No.- 16/ IV f -101/ Admin(A) dated 27.05.2017, abroad tour by any officer shall not be availed of during working days of court except in special circumstances. But my tour is not for pleasure. My wife was suffering from Cardiac Arrythmia when she was in India but at present, she is facing same problem of Cardiac Arrythmia and she needs treatment. She has an appointment in month of August 2024 for check-up and treatment. During her treatment my presence will help and support her. My wife will get treatment in Surrey and she will stay at my son's residence for the duration of her treatment. My wife needs me a lot in this emergency. Being a father and husband, I also must fulfil my responsibility toward my family. Coming back to India for treatment will not be not a viable option for my family as it will jeopardize my son and wife's career and job, and study of my daughter also and there will be three times the financial burden on my family to come India and going back to Canada. So, it is necessary for me to visit Canada and spend some valuable days with my family and care of my wife's treatment for fulfil my responsibility toward my family in any way I can.

My son is staying in a rented house, and I will be staying with my son's residence at 9138 134B St Surrey, BC and my wife will get treatment in Surrey and she will also stay at my son's residence for the duration of her treatment. So, there will be no expenditure for accommodation. My visit to Canada entails only fare expenditure which is approximately about ₹ Two lac only. I am enclosing my bank statement for your kind perusal.

It is humbly submitted that in view of abovementioned emergency and special circumstances, I want to go to Canada from 04.08.2024 to 01.09.2024 after availing Earned Leave from 05.08.2024 to 31.08.2024 (with prefix 04.08.2024 (Sunday) and suffix with 01.09.2024 (Sunday). My proposed visit to Canada will be commenced on 04.08.2024.

It is also submitted that; last time I have visited Canada from 23.12.2023 to 21.01.2024 with the permission of Hon'ble High Court and came back within stipulated time. I already applied for visa to visit Canada and the same was granted to me with validity till 01.10.2026. Therefore, I have valid visa to visit Canada. I am submitting my application before time because the air ticket may be available at cheaper rate.

In light of Hon'ble High Court Circular No.- 16/ IV f -101/ Admin(A) dated 27.05.2017, I declare the following,

- (a) That by my visit to Canada, no dilemma is likely to create before the Government of India or before the Government of UP.
- (b) That my any request to visit abroad was not refused to me earlier.
- (c) That last time, I also applied for permission before Hon'ble Court to visit Canada from 23.12.2023 to 21.01.2024 the same was granted and I came back to India within stipulated time.

In view of abovementioned emergency and special circumstances, I humbly request to place my application before Hon'ble Court to kindly consider my application to allow me to visit Canada for care of my wife during her treatment and meet my family. I shall be highly obliged.
