- As per the recommendations of Justice Reddy Committee constituted by MHRD on the directions of Hon'ble Supreme Court dated 03-11-2017 in Civil Appeal No. 17869-17870 filed by Orissa Lift Irrigation Corp. Ltd Versus Rabi Sankar Patro & Ors. and its acceptance by the MHRD, the HEIs are informed that if any deviation is noticed, the same would entail not only withdrawal of permission / recognition for such ODL course but also for other courses offered by the institution, on regular and conventional mode.

Note:

- The HEIs shall strictly abide by all the provisions contained in the UGC (ODL) Regulations, 2017 and its subsequent amendments.
- The list will be updated from time to time on receipt of affidavits from HEIs under Category - I.
