**Subject-** Submission of information/ intimation regarding the purchase of movable property (Car) in light of circular C.L. no. 25/Admin(A) dated 13.07.1998 regarding purchase of new Maruti Ciaz car.

Respected Sir,

This is to furnish the following information in the light of the **Circular Letter No. 25/ Admin. (A) dated 13th July, 1998** issued by the Hon'ble High Court of Judicature at Allahabad.

1. I joined the Uttar Pradesh Judicial Services dated on **01 March 2024**.
2. I was getting a Gross Salary of **Rs. 144560/-** (One Lakh Five Hundred Eighty-Three) during the Month of March/April, while the Take Home salary was **Rs. 129360/-** (Eighty-Four Thousands) at that period.
3. I have purchased a new car on **17.04.2024** named '**Maruti Ciaz Smart Hybrid Zeta15L 5MT**' from the reputed car manufacturing company 'Maruti Suzuki India Ltd.' from its dealership showroom 'Deep Motors Nexa, Village Devkhari, PO- Bhawarnath, Azamgarh' located at Village Devkhari, Bhawarnath, District- Azamgarh, Uttar Pradesh, 276001. Sir, the **total price paid by me for the purchase of above-mentioned car was Rs. 11,40,000/- (Eleven Lakhs Forty Thousand Rupees)**.
4. I have **not** taken any advance or the Loan from the Hon'ble High Court.
5. I took a **Car Loan of Rs. 10,40,000/- (Ten Lakhs, Forty Thousands Rupees)** from the **STATE BANK OF INDIA, HARBANSHPUR BRANCH, AZAMGARH**, Branch Code :00014, to pay the complete amount to the dealer. The Loan Account No. for the same is **42889629401**. The Loan EMIs are payable for **84 month** (7 years) at **Rs. 16,972/-** (Sixteen Thousand Nine Hundred Seventy Two Rupees)/monthly. (Loan Sanction Letter shown in Annexure).
6. I have purchased a **new car**.
7. The property purchased was a **movable property** of the description given in Point No. 3.

8. I have purchased the above-mentioned car from the reputed dealer **Deep Motors Nexa, Village Devkhari, PO- Bhawarnath, Azamgarh**, having its **registered address** at Village Devkhari, PO- Bhawarnath, Azamgarh.

9. Yes, **the dealer is well known, reputed and regular Maruti Suzuki Car dealer** of Azamgarh and adjacent Districts.

10. No, **the dealer is nowhere related to the applicant**. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.

11. I have made **all the payments towards purchasing of the said vehicle from my Saving Bank (Salary Account) Account No. 42765986192** of STATE BANK OF INDIA, HARBANSHPUR BRANCH, AZAMGARH. The whole amount was paid in following manner-:

1. **A Bank transfer of Rs. 1,00,000/- (One Lakh Rupees)** was made by the bank on my instructions from my Savings Bank Account No. 42765986192, which is my **salary account**, to the Dealer's account on dated 16.04.2024. **(Shown in Annexure)**.

2. **A Car Loan of Rs. 10,40,000/- (Ten Lakhs, Forty Thousands Rupees)** was taken from the STATE BANK OF INDIA, HARBANSHPUR BRANCH, AZAMGARH to pay the remaining amount to the dealer. **(As mentioned in Point No. 5 above) (Shown in Annexure)**.

- F.** Statement of Loan taken by me from the aforesaid branch of the State Bank of India situated at Azamgarh with **Account No.:**42889629401.
- G.** The Registration Certificate issued by Transport Department, Kaushambi regarding the purchased vehicle.
