**Subject-** Submission of information/ intimation regarding the purchase of movable property (Car) in accordance with the Rule 24 of the Government Servants Conduct Rules 1956.

**Respected Sir,**

I want to furnish the following information in the light of the **Circular Letter No. 25/ Admin. (A) dated 13<sup>th</sup> July, 1998** issued by the Hon'ble High Court of Judicature at Allahabad. Sir, I want to submit that-

1. I joined the Uttar Pradesh Judicial Services on 1<sup>st</sup> January 2020 vide notification No. 4221/ Admin. (Services)/ 2019 dated 13<sup>th</sup> December 2019.
2. I was getting a Gross Salary of Rs. 150480/- (One Lakh fifty thousand four hundred eighty only) during the Month of March/April, while the Take Home salary was Rs. 122137/- (One Lakh twenty two thousand one hundred thirty seven only) at that period. The salary for the month of April, May and June still not received.
3. I have purchased a new car on 19.06.2024 named 'MG Hector Plus, SHARP PRO 7 S Diesel' from the reputed car manufacturing company 'MORRIS GARAGES' from its dealership showroom 'DEE AUTOTECH PVT. Ltd, 4 Sardar Patel Marg Civil Lines, Prayagraj'. Sir, the total price paid by me for the purchase of above-mentioned car was Rs. 25,50,000/- (Twenty Five Lakh fifty thousand only).
4. I have not taken any advance or the Loan from the Hon'ble High Court.
5. I took a Car Loan of Rs. 13,00,000/- (Thirteen Lakhs) from the State Bank of India, PBB Allahabad to pay the complete amount to the dealer. The Loan Account No. for the same is 43073360232. The Loan EMIs are payable for 84 month (7 years) at Rs. 21048/- (Twenty one thousand forty eight only) /monthly. (Shown in Annexure)
6. I have purchased a new car.
7. The property purchased was a movable property of the description given in Point No. 3.
8. I have purchased the above-mentioned car from the reputed dealer "DEE AUTOTECH PVT. Ltd, 4 Sardar Patel Marg Civil Lines, Prayagraj".
9. Yes, the dealer is well known, reputed and regular MORRIS GARAGES Car dealer of Prayagraj and adjacent Districts.
10. No, the dealer is nowhere related to Me. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.
11. I have made all the payments towards purchasing of the said vehicle from my Saving Bank Account No. 20018480760 of State Bank of India, Sanigawan, Kanpur Nagar Branch. The whole amount was paid in following manner:
  - (i) A Payment of Rs. 9,00,000/- (Nine Lakhs Rupees only) was made through cheque no. 015540 Dated 19.06.2024 and of Rs. 3,50,000/- (Three Lakhs fifty thousand

- Rupees only) was made through cheque no. 015541 Dated 19.06.2024 from my Savings Bank Account No.20018480760 to the Dealer's account on dated 19.06.2024. **(Shown in Annexure)**
- (ii) A Car Loan of Rs. 13,00,000/- (Thirteen Lakhs) was taken from the State Bank of India, PBB Allahabad Branch to pay the remaining amount to the dealer. **(As mentioned in Point No. 5 above)**


